The Directorate of Sports, Merged Areas invites technical and financial proposals from qualified local and national event management firms/service providers having at least 3 years of relevant experience for the framework contract for hiring services for implementation and execution of sports events, including refreshments, catering services, and printing of Panaflex banners. Proposals are to be submitted online through the E-Pak Acquisition and Disposal System (EPADS) under National Competitive Bidding in accordance with KPPRA Rules, 2014.

**TERMS & CONDITIONS: -**

1. Bidders must be registered with KPPRA; hold valid NTN and GST certificates, and appear on the Active Taxpayer List (ATL). A valid registration certificate from the Registrar of Firms (Form-H) and SECP registration must be provided where applicable.
2. Procurement will be conducted through the Single Stage–Two Envelope procedure under Rule 14(2) (b) of the KPPRA Rules; 2014. The bidder must clearly mention their postal address, valid email address, and active contact numbers.

Late submissions will not be entertained.

6. Bidders must submit a Bid Security of 2% in the form of a Call Deposit Receipt (CDR), in favor of the Director General of Sports, Government of Khyber Pakhtunkhwa.
7. A pre-bid meeting will be held on 16<sup>th</sup> January 2025 at 12:00 Noon in the office of The Director Sports Merged Areas Peshawar Sports Complex Peshawar.
