


Terms and Conditions:

1. Bid Solicitation Documents uploaded by this Office, can be downloaded from the official EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website after publishing NIT. The bid documents will be filled neatly and a clear scanned copy of the same shall be uploaded at the time of apply through EPADS.
2. **The Contractors/Firms must have to upload their profile documents and relevant experiences on EPADS for the advertised works.**
3. **Cutting and overwriting** in the bid documents shall not be acceptable.
4. The bid securities must be prepared in favor of the **Assistant Director (Senior), LG&RDD Tehsil Headquarter Babozai, District Swat**. These securities shall be uploaded on the EPAD system at the time of bid submission and the same uploaded original bid security must be physically delivered to the office **Assistant Director (Senior) LG&RDD Tehsil Headquarter Babozai Swat, located opposite circuit house Gulkada No.1**, up to the closing time of bid.
5. The bid securities for the work must be prepared after publishing of NIT and before closing time of electronic bid.
6. **All the bid securities i.e. submitted CDRs for the advertised work shall not be released to any bidder before awarding of the contract as per KPPRA Notification S.R.O (29)/vol: 1-40/2025-26 dated 29th October 2025/699-711.**
7. Rates may be offered as %age above or %age below or At-Par on Engineer Estimates.
8. Last date and time for Online Clarification is **04:00 PM on 27th January, 2025.**
9. The contractors quoting their bids up to a limit of 10% below on Engineer Estimate shall submit bid security @ 2% only of Engineer Estimate.
10. The contractors quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as **non-responsive** and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
11. Similarly, a contractor, quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the **detailed rate analysis** and / or required amount of **additional security**, then the said bid shall be considered as **non-responsive**. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.

12. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
13. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
14. The contractor or his representative must be present at time of electronic bids opening.
15. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
16. Any bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
17. Bids will remain valid for 120 days from the closing date of bids.
18. All applicable taxes shall be recovered in accordance with the directives of the government.
19. The PEC and KP-PPRA registration (Active Tax Payer) must be valid for current financial year 2025-26.
20. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KP-PPRA Act & Rules.
21. All material testing and all sorts of tests will be performed by contractor on the demand of procuring entity.
22. The Additional security shall be released to the contractor after completion of approved works as per KPPRA Notification S.R.O (14)/vol: 1-24/2021-22: dated Peshawar, the May 10, 2022/6058-71.
23. The Work order will be issued to the lowest responsive bidder subject to the availability and release of funds.
24. The successful bidder shall be responsible to previews satisfactory certificates of the work done from the concerned MPAs.
