TENDER FOR SUPPLY OF FRUIT PLANTS.

Department of Agriculture Extension Shangla intends to purchase fruit plants with an estimated cost of Rs.1.3 million.

Sealed tenders are invited from well reputed suppliers. The tender shall reach to the office of the undersigned up to 2nd February 2026 till 11:00AM. The tenders will be opened by the committee in the presence of the bidders or their representatives at 11:30 AM on the same day.

Terms and conditions:

- 1) The bidder shall be registered with Federal Seed Certification and Registration Department (FSCRD) valid (Registration Certificate).
- 2) The bidders shall have experience of supply of fruit plants to Government / Non Government organizations (supply orders).

- 3) The plants will be supplied by the successful bidders in the nursery / Collection point in swat preferably near Mingora. The farmers will collect plants from the nursery or collection point as per allotment by the Extension Department Shangla.
- 4) The cost of tender could increase or decrease subject to availability of funds.
- 5) The plants will be inspected in the fruit nursery farm by a technical committee and the acceptance of bid will be subject to the recommendation of the committee.
- 6) The plants are to be supplied as per supply order of the District Director Agriculture Extension Shangla.
- 7) The successful bidder will provide indemnity bond on stamp paper, for ensuring the quality of the supplied plants.
- 8) The bid shall comprise a single stage two envelops as per KPPRA Rules 2014.
- 9) Each bidder will provide the financial proposal and technical proposal and the Envelop will be marked as financial proposal and technical proposal separately.
- 10) The bidders shall clearly and boldly mark the tender number, its description and date / time of opening at the face of sealed bid / envelop.
- 11) All applicable taxes will be borne by the successful bidder.
- 12) Bidders must be registered with Khyber Pakhtunkhawa Revenue Authority (KPRA).
- 13) Each bidder will attach call deposit @ 2% of the estimated amount.(CDR) / P/O/DRR Pay order/ Demand Draft in the name of District Director Agriculture Extension Shangla as earnest money with FINANCIAL PROPOSAL and also enclose a photocopy of CNIC.
- 14) No offer shall be considered if
 - (i) Received without earnest money or from un registered firm, for the items mention in this tender.
 - (ii) If received after the time and date fixed for its receipt.
- 15) The undersigned reserves the right to reject the bids showing a valid reason.
