TERMS AND CONDITIONS

1. Bid Solicitation Documents can be downloaded from EPADS website (<https://kp.eprocure.gov.pk>) before the submission date/time.
2. Complete detail of bid security in shape of CDR i-e Bank Name, CDR Number(S), and Date(s) must be submitted electronically on the EPADS and original Copies of Call Deposits of Bid Security, Bidding Entry Fee and additional securities (if any) should reach to the Office of Executive Engineer C&W Division Kohistan Lower before closing time.
3. In case of failure to submit the original bid security and additional security instrument before the date and time, the bidder shall be debarred for a period of one year.
4. In case of violation for second time, the bidder shall be blacklisted for a minimum period of three (03) years in accordance with Section 29 of the KPPRA Act read Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014.
5. All the bid securities i-e submitted CDRs for the advertised work will not be released to any contractor before awarding the contract as per KPPRA Notification S.R.O.(29)/Vol: 1-40/2025-26 dated October 29, 2025/699-711.
6. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, under Finance Act No. XXI of 2013 and must be active tax payer.
7. Rates may be offered as % above, % below or At Par on Engineer's Estimate.
8. The instruction issued by KPPRA vide Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10/05/2022 will be applicable.
9. The additional security shall be released to the contractor in four installments i.e 1st installment of 25% to be released upon completion of 25% of the project, 2nd installment of 25% to be released upon completion 50% of the project, 3rd installment of 25% to be released upon 75% of the project and the remaining amount to be released after completion of the project
10. Bids will remain valid for 90 days from the closing date of the bids.
11. Pay order is not acceptable.
12. The procuring entity has the authority to reject a bid or all the bids assigning cogent reason(s) under Rule-47 and go ahead for Re-bidding under Rule-48 of KPPRA Rules 2014.
