**Terms and Conditions:**

- Standard Bidding Documents along with Tender form can be downloaded from the official EPADS website i.e. ([www.portalkp.eprocure.gov.pk](http://www.portalkp.eprocure.gov.pk)) after publishing NIT. The tender form will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
- While the original tender form along with original bid securities and detail rate analysis (if applicable) complete in all respect must be delivered through courier to the Office of AD LG&RDD District Khyber before closing time of bid.
- Cutting/overwriting/manipulation in the tender form will not be acceptable and Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into his disqualification and the same contractor will be considered as non-responsive.
- The rates may be offered as %age above or %age below or at-par on engineer estimate.
- The last time and date for online clarification is up-to 05:00 pm on 04-02-2026.
- The securities 8% & 2% shall be in shape of call deposit in favor of the **Assistant Director LG&RDD District Khyber**. No CDR bearing name other than Assistant Director LG&RDD District Khyber shall be consider as valid.
- The eligible contractors/firms must have specialized & relevant codes of Pakistan Engineering Council (PEC) for the specified works.
- The contractors quoting their bids up to a limit of 10% below Engineer Estimate shall submit bid security @ 2% only of Engineer Estimate.
- The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a contractor, quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
- In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.**
- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing date & time of the bid.
- In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
- Any electronic bidder who provides false, or materially inaccurate or incomplete or do not send information in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
- Bids will remain valid for **180 days** from the closing date of bids.
- The firms/contractors who wants to participate in tendering process may registered themselves with the EPADS for gaining their unique username and password.
- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under the Khyber Pakhtunkhwa Finance Act 2013.
- The PEC and KPRA registration (Active Tax Payer) must be valid for current Financial Year and attached with the Bids, all the taxes as per kppra rule will be applicable.
- Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
- KPPRA Notification No. S.R.O (29)/volume:1-40/2025-26 Dated: 29 October 2025 regarding Debarment & Blacklisting is incorporated and will take its effect accordingly.
- The date & time of closing/ opening of bid shall be reckoned as per EPAD systems.***
