Hospital Director, MTI-Mardan Medical Complex (MMC) Mardan invites sealed bids under National Competitive Bidding for the **Provision of Liquid Medical Gas at MTI Mardan** in light of rule 6 (a) "**Single Stage Single Envelope**" procedure of KP-PPRA Rules 2014, from Manufacturers only, registered with the Income / Sales tax, reflected on Active Taxpayer List (ATL) of FBR.

The interested bidders shall submit their bid by uploading scan copy on **EPADS System** on or before **09-02-2026 (Monday) 11:00 hrs**, which shall be opened on the same day at **09-02-2026 (Monday) 11:30 hrs** on EPADS in Conference Room of the Administration Block of the Institute. The bidders shall upload all the mandatory and relevant documents alongwith the bid security on the EPADS. Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.

You are hereby requested to quote your best and final price (Per Cubic Meter) including all applicable taxes for a period ONE year extendable for another year up-to a maximum three years by considering the following points.

- i. Liquid Medical Gas shall be utilized for the MTI-MMC Mardan and its allied institutions.
- ii. Bid Security (in original) @ Rupees 2 Million in the form of CDR/Demand Draft/Pay Order or Bankers Cheque should be uploaded on EPADS and submitted in physical before closing date & time.
- iii. Contract duration is ONE Year from the date of signing of contract, extendable for another year up-to a maximum three years.
- iv. Initial safety measures at the time of installation will be responsibility of the firm concerned.
- v. Maintenance and yearly calibration of the installed Tank shall be responsibility of the firm concerned at its own cost.
- vi. Only Civil work will be executed by the Hospital.
- vii. Comparison of bids shall be made on the basis of rates quoted by the firm **Per Cubic Meter** and no hidden / additional charges shall be accepted during the contract period.
