2. Technical bids will be opened at 02:00 P.M on the same date given above, by the bids evaluation committee in the Office of Executive Engineer PHE Division District Mohmand, in the presence of bidders or their representative.
3. Date for opening of financial bids of the bidders will be intimated accordingly.
4. Contractors/bidders would have to include the BOQ showing the sales tax bifurcation details (duly filled) (received vide KPPRA Notification No.S.R.O (10)vol:1-18/2020, dated 10.02.2021) provided in the bidding documents along with call deposit & other requisite documents in the Financial Bid Envelope. In case of its non submission, bids would be considered as Non responsive.
5. Solarization of DWSSs will be carried out in accordance to standard specification notified by SO (B)11-10/Solar-Panel/PBC/2025-26/C&WD: dated: 30.07.2025

6. Technical Design should be based on Technical aspects of the scheme provided in the Technical documents and rates should be quoted accordingly in the financial bid.
7. Percentage of earnest money 2% of the engineer estimate in shape of call deposit in the name of the Executive Engineer PHE Division District Mohmand and will be enclosed in the financial bid clearly marked as financial bid.
8. The bid security, Additional Security, and detail rate analysis shall be submitted as per KPPRA Notification NO.S.R.O (14) /Vol: 1-24/2021-22/6058-71 dated Peshawar, the 10 May 2022, along with the bid in a sealed envelope before the closing date and time to office of the undersigned
