1. Bidding shall be online through EPADS as per rule, “Single Stage Two Envelopes Procedure”/ 6(2)(b) of KPPRA rules 2014. This tender notice can be downloaded from KPPRA & BISE Kohat (www.bisekt.edu.pk) websites. Complete set of Tender documents can also be obtained from the office of the undersigned during office hours. The bidders shall be bound to fill and submit electronic bid through EPADS only, and attach scan copies of required documents (online).
2. Bidder should be registered with Income Tax and relevant Sales Tax Departments of Government of Pakistan/KPPRA and should be reflected on the Active Taxpayer Lists (ATL) of FBR and KPPRA.
3. Bids shall be submitted through EPADS up to 12/02/2026, 10:30 AM, which will be opened on the same date i.e. 12/02/2026 in conference room of BISE Kohat at 11:30 AM in presence of the bidders or their authorized representatives who may like to attend.
4. Bids must be accompanied by a bid security of Rs.100,000/-(fixed) in shape of CDR deposited in favor of the **Chairman**, Board of Intermediate & Secondary Education Kohat . Bids without CDR/bid security shall be declared as non-responsive.
5. Interested firms are requested to prepare a compliance sheet for the Cloud Hosting as per Specifications.
6. The subject services are initially required for the period of one year with effect from the date of agreement and can be extended for the period of another term. The Successful bidder may be in a position to commence services immediately after award of the contract.
7. The service shall be required round-the-clock.
8. In case of closed/forced holiday etc. tender opening time/date will be considered as the next working day.
