The E-bids are invited under single stage – **Single envelope method of KPPRA Rules 2014 (Financial)**.

Following are the terms & conditions:-

1. The interested and eligible bidders/contractors/suppliers/firms duly registered on EPAD link <https://kp.eprocure.gov.pk/#/supplier/registration> are eligible to apply under Single stage single envelope method of KPPRA Rules. The E-bid must be submitted/ uploaded through EPAD before 11/02/2026. The bid on EPADS(e-bidding) shall be opened on the same day at 11:30 am. The bid will be quoted for each Package separately.
2. The procuring entity shall evaluate the proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements.
3. ORIGINAL two(2%) CDR of the bid price in the name of "Divisional Forest Officer, Kohat Forest Division, Kohat(Separate for each package) and an affidavit regarding original 02% CDR shall be separately sealed and put in separate envelopes and marked as such. The envelopes containing the ORIGINAL CDR and an affidavit regarding 02% CDR will be put in one large sealed envelope and shall reach on below given address before the closing date and time.
4. Cutting / overwriting /manipulation in the tender will not be accepted and any mismatching among the scanned copy submitted through EPAD and submitted in hard will lead into his disqualification and the same contractor will be considered as non – responsive.
5. All applicable taxes including Sales tax, Income tax, KPRA taxes, and stamp duties etc. as per Government Rules enforced shall be applicable.
6. The eligible contractors and firms must have relevant codes of PEC for construction as per their specification
7. All the rate shall be quoted on (FOR) basis.
8. In complete, conditional, late submitted, or manual bids shall not been entertained /accepted.



9. Evaluation will be done package wise.
10. The competent authority reserves the right to accept or reject any or all tenders with cogent reason as per KPPRA Rules.
11. The contractor quoting their bids more than 10% below up to 20% below on Engineer estimates shall submit along with their bid 8 % additional security of Engineer estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be consider as Non- responsive and 2% bid security shall be forfeited in favor of government and the second lowest bidder and so on will be consider accordingly.
12. Similarly quoting bid more than 20% below shall submit with his bid in addition security on Engineer estimate cost equal to the differential amount of submitted bids and engineer estimated along with detail rates analysis. In case of more than 20% below bids if the bid is not accompanied by the detail rate analysis and /or required amount of additional security, than the said bid shall be consider as non-responsive. All the security submitted along with such non responsive shall be forfeited in favor of Government and the second lowest bidder and so on consider accordingly.
13. The procuring entity may offer the contract to next lowest bidder after two due diligences in the context of financial difference between such two bids or may advertise procurement opportunity or fresh.
14. The bidder should submit their bids as per KPPRA notification No. SRO (14 volume 1-24/2021-22 Dated 10-05-2022)
15. The original tender form along with original bid security, KPPRA enlistment, C&W enlistment, PEC Registration and detail rate analysis (if applicable).
16. All bidders are required to be registered with KPRA under finance act 2013 Act No. XXI of 2013 must be active tax payer.
17. Any bidder who provide incorrect information /documents shall stand disqualify & his CDR will be forfeited.
18. No pay order and Bank draft will be acceptable except call deposit of scheduled Bank or otherwise the bid will be declare as non – responsive.
19. All other terms will be as per KPPRA rules, PEC guideline, SBDs & other relevant laws.
20. The PEC and KPPRA registration (Active Tax Payer) must be valid for Current Financial Year and attached with bids.
