Medical Teaching Institution (MTI) Mardan, Khyber Pakhtunkhwa was established under Khyber Pakhtunkhwa Medical Teaching Institutions Reforms Act, 2015 to improve performance, enhance effectiveness, efficiency and responsiveness for the provision of quality healthcare services to the people of the Khyber Pakhtunkhwa.

Sealed bids are invited from the eligible individuals / well established contractors to run the Car Parking Area (Outside Area Only) in front of MMC Hospital having relevant experience, under Single Stage One Envelop procedures of KP-PPRA Rules 2014. The bidders must be registered with the Income / Sales tax and KP-Revenue Authority (KRA), reflected in the Active Taxpayer List (ATL) of the Federal Board of Revenue.

Bid Solicitation Documents containing detailed descriptions including qualification criteria and other terms & conditions, may be obtained from the office of the undersigned between 09:00-15:00 hrs on any working day (Monday to Friday) by depositing a sum of Rs.3000/- as "Non-Refundable" from the date of publication of this advertisement in the newspaper till last date for submission of bids. The bidders are required to submit bid security (in original) of an amounting to Rs. 2,500,000/- (Two Million Five Hundred Thousand Only) in the form of Call Deposit Receipt (CDR), Demand Draft (DD), Pay Order or banker's cheque in the name of "Hospital Director MMC Mardan".

Bids complete in all respects must reach the undersigned by 11:00 hrs on **10.02.2026 (Tuesday)** which will be opened at 11:30 hrs on the same day in the Conference Room of the Administration Block, in the presence of the committee and the bidders / representatives who may choose to attend.

**OTHER TERMS & CONDITIONS:-**

1. Only those bidders can participate who purchase tender documents from the undersigned office.
2. The successful bidder will submit **SIX MONTHS RENT IN ADVANCE** before signing the contract.
3. The bidders must be registered with KP- Revenue Authority.
4. The successful contractor will not sublet the contract to any other person/firm.
5. Bid Security in the form of Open cheque or Cash shall not be accepted.
6. Copy of CNIC, NTN and KP-Revenue Authority of the bidder must be attached with the bid.
7. The bidders shall submit an affidavit (attached in the bid documents) that he has not been blacklisted nor involved in any litigation by / with any of the Federal/Provincial departments.
8. The bidders shall not be eligible to bid if they are under a declaration of Ineligibility for corrupt and fraudulent practices issued by any government organization.
9. Late bids shall not be entertained.
10. The Competent Authority, on recommendation of the Asset Disposal Committee, shall award the contract in light of Rule 50-D(7) of KP-PPRA Rules 2014 to the bidder with highest quoted bid.
11. Competent Authority reserves the right to reject any or all the bids by assigning reasons as per provisions contained in Rule 47 of KP-PPRA Rules 2014.
