General Terms and Conditions of the Contract

1. The tenders should examine carefully the General and Special Conditions of Contract and Specification supplied herewith. He should visit and inspect the site at his own responsibility and at his own expense and obtain all the information, which may be necessary for purpose of making a tender.
2. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate.
3. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of the University and the second lowest bidder and so on will be considered accordingly.
4. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
5. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
7. After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not in the form of bank guarantee.

8. The Additional Security shall be released to the contractor in four installments i.e. 1 st installment of 25% to be released upon completion of 25% of the project, 2 nd installment of 25% to be released upon completion of 50% of the project, 3 rd installment of 25% to be released upon completion of 75% of the project and the 4 th installment of 25% to be released after 100% completion of the project
9. The bids received late shall not be considered.
10. In case bids become tie, the award of contract shall be decided through a fax toss which shall be binding and final.
11. The bidders are at liberty to seek any clarification or further information from the office of the undersigned as desired.
12. All federal and provincial duties/ stamp duty/ taxes will be recoverable as per directives of the government issued from time to time.
13. If any documents submitted along with bid documents found false/ bogus, the registration of the contractor/ firm shall be stand cancelled/ blacklisted.
14. Any disfiguring/ overwriting manipulation in the tender shall be liable to rejection.
15. If any documents submitted along with bid documents found false/ bogus, the registration of the contractor/ firm shall be stand cancelled/ blacklisted.
16. Any disfiguring/ overwriting manipulation in the tender shall be liable to rejection.
17. Only the first two figures after decimal of the rate will be considered for evaluation of the bid.

19. The tender documents duly completed and each page signed by the Contractor shall be received and opened by the Director Works, AWKUM in the presence of the Convener and members of the works committee.
The Contractor who,
 - (i) Withdraws or modifies his Tender.
 - (ii) Does not actually start the work within **07 (Seven)** days of the issue of letter of acceptance, shall loose his Earnest Money and the same shall be forfeited in favor of the University.
20. The work will confirm to lay down standard specification. The work not conforming to the standard specifications will be demolished by the Contractor. No claim in this regard will be entertained for payment.

- 21.** 8% (Eight percent) of the amount payable to the Contractor shall be deducted from his each bill and retained by the University by way of Security Deposit. The same will be released after successful completion of defect liability of One Year.
- 22.** The University shall not be involved in any case if a loss or damage occurs to any person or property whatsoever arising out or as a consequence of the construction and the maintenance of works, and all liabilities in this regard shall be borne by the Contractor. The Contractor shall confirm in all respects with the provisions of any ordinance, Law Rules or Regulations of authority, which may be applicable to the works or temporary works.
- 23.** Upon the completion of the work the contractor shall remove from site all plants, temporary hutting if put up, rubbish and refuse material of any kind and leave the whole of the site clean and tidy.
- 24.** The university shall have the power to order at any time the removing of any materials or work executed which is not in accordance with the contract and to have them substituted/ rectified and re executed at the contractor own expenses with proper and approved materials and methods within a reasonable period as decided by Director Works. In case of default by the contractor to carry out such orders, the University shall have the power to have such works removed and re executed through other arrangements at the sole risk, cost and responsibility of the contractor.
- 25.** The work shall be completed within the prescribed period and time shall be considered as the essence of the Contract. In case of default on the part of the Contractor to complete and deliver the work within the prescribed period, he shall pay to the University Liquidated Damages for delay at the rate of one fifth percent of Agreement sum per day of delay in completion, maximum up to Ten percent of the Agreement sum. However, should an extra or additional amount of work be ordered upon the contractor or other circumstances of any kind whatsoever may arise such as to fairly entitle the Contractor to an extension in the completion time, the Contractor shall properly lodge the claim to extension with the Director Works when such work has been ordered or the circumstances has arisen. The Director Works shall determine and will recommend such period of extension for approval from the Vice Chancellor. Such extension of time if approved by the Vice Chancellor shall be final and binding upon the Contractor.

26. The University shall have the power to order variation in the form, quality or quantity of the works or any part thereof and shall have the power to order the Contractor to do so and the Contractor shall comply with such orders including the following:-

- a) Increase or decrease in the quantity or scope of any work included in the Contract.
- b) Omit any such work.
- c) Execute the additional work necessary for the completion of as such would be entertained on this account.

27. To the intent that the works shall, at or as soon as practicable after the expiration of the period of contract, be delivered to the University in a good and perfect condition to the satisfaction as that in which they were at the commencement of the period of contract, the contractor shall execute all such work of repair, cutting filling, re-leveling/grading, rectifications' and making good of defects, imperfections, shrinkage's, consolidation or other faults, of faulty executed work as may be required of the Contractor in writing by the Director Works during the period of Contract/Maintenance.

SPECIAL CONDITIONS OF THE CONTRACT

1. Inspection of materials.

All materials shall be subjected to inspection and shall be approved by the director works or his authorized representative before the same are fabrication or installed in position. The Director Works may reject such materials as are considered by him to be below standard specifications, size or quality. The Contractor shall provide all labor at his own expense for handling during inspection. Any materials rejected by the Director Works shall not be used and shall be removed from site by Contractor.

2. Work to be opened for inspection.

All works under or during the course of execution in pursuance of the contractor, whether at site or at Contractor's workshop shall, all times, be opened for inspection and supervision of the Director Works or his authorized representative at all times during the usual working hours, either himself be present to receive the instructions or any responsible agent duly accredited in writing, present for the purpose. Instruction given to the Contractor's agent shall be considered to have the same force as if these had been given to the Contractor himself.

4. Specifications

The work will confirm to standard specification. The work not conforming to the standard specifications will be demolished by the Contractor. No claim in this regard will be entertained for payment.

5. Laboratory test

The director Works has the power to order material quality assurance test which he deems necessary and the cost of such tests will be done by the contractor. No claim in this regard will be entertained for payment.
