

GENERAL TERMS AND CONDITIONS

1. Bidding documents including instructions to bidders can be downloaded from EPADS web site (www.eprocure.gov.pk).
2. Technical Bids will be opened on the same day at **2:00 PM**, in presence of the contractors or their authorized representative, who opt to attend.
3. The contractor / bidders while quoting their rates shall submit 2% bid security (CDR) and additional security as per KPPRA Notification No. S.R.O.(14)/Vol:1-24/2021-22 dated: 10-05-2022.
4. In case, the bidder quotes more than 20% below on the estimated cost and on EPADS the bid is not accompanied by detailed rates analysis/or required amount of Additional Security then the bid shall be considered as **Non-Responsive**. All the bid securities submitted along with such non-responsive bid shall be forfeited and in favor of Provincial Government and second lowest and so on shall be considered accordingly.
5. In case detailed rate analysis submitted is not obvious and non-convincing in view of the tender opening committee, the bid shall be declared as **Non-Responsive**.
6. If the evaluated electronic bids of two or more bidders are equal then successful bid shall be decided on the basis of draw.
7. A Pre-Bid meeting shall be held at office of Superintending Engineer PHE Circle Bannu on 05-02-2026 at 11:00 AM.
8. The Competent Authority reserves the right to reject any or all the bids by assigning cogent reason(s)/(Rule-47 of KPPRA 2014).
9. No bank Guarantee is acceptable to this office.
10. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid).
