

NOTICE INVITING TENDER ON E-PAD SYSTEM

(SINGLE STAGE ONE ENVELOPE)

Directorate of Non Timber Forest Products, Khyber Pakhtunkhwa Invites bid through EPADS, from the eligible contractors / firms in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 on "Single stage one envelope system under Rule 6(2)(a) under ADP project titled "**LIVELIHOOD IMPROVEMENT AND POVERTY REDUCTION THROUGH NON-TIMBER FOREST PRODUCTS ACTIVITIES IN KHYBER PAKHTUNKHWA**" Project Code No.210503. The bidder shall be registered with: (I) E-Pak Acquisition and Disposal System (EPADS) (II) Pakistan Engineering Council (PEC) for the year 2025-2026 (III) Khyber Pakhtunkhwa Revenue Authority (KPRA) (active) (IV) Federal Board of Revenue (FBR) (NTN active) having sufficient experience in the field of work given below, on percentage above/below on BOQ/Engineer cost estimate (MRS-2021 1st Bi-annual) for the below mentioned work is as under: -

TERMS & CONDITIONS:

1. The bidding documents can be downloaded from the official EPADS website i.e. (<https://eprocure.gov.pk/>) after the publishing NIT of KPPRA the BOQ will be filled neatly and clear and a scan copy of the same will be uploaded at the time of apply (Bid Submission) through E-PADS.
2. Bids and Original call deposit receive by hand will not be acceptable sealed bids send through registered mail / courier service should reached to the office of the undersigned upto **11:00 am dated 17/02/2026** and will be opened on the same day at **11:30 am** in the presence of contractors / authorized representatives. In case of holiday or due to unavoidable circumstances on the opening day, tender will be opened on the next day at same time.
3. 02% earnest money in shape of call deposit (in original) in the name of undersigned must be attached with the tender.
4. Stamp duty @ Rs.18,750/- should be deposited separately as per Government Rules.
5. Incomplete bids / received after due date / time will not be entertained.
6. If two or more firms / parties offer the same rate / cost for the above construction works then the undersigned reserves the rights to accept the rate / cost of any firm / party.
7. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals as per KPPRA Rule 47.
8. The procuring entity shall communicate reason / grounds for rejection to any contractor who submitted a bid or proposal as per KPPRA Rule 47.
9. All the testing material cost from the laboratory will be borne by the contractor as per Engineer advice.
10. Incomplete / conditional bids shall not be accepted.
11. The contractor quoting their bids more than 10% below up to 20% below on Engineer estimates shall submit along with their bid 8% additional security of Engineer estimated cost

in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as Non-responsive and 2% bid security shall be forfeited in favor of government and the second lowest bidder and so on will be consider accordingly.

12. Similarly quoting bid more than 20% below shall submit with his bid in addition security on Engineer estimate cost equal to the differential amount of submitted bids and engineer estimated along with detail rates analysis. In case of more than 20% below bids if the bid is not accompanied by the detail rate analysis and/or required amount of additional security, than the said bid shall be consider as non-responsive. All the security submitted along with such non responsive shall be forfeited in favor of Government and the second lowest bidder and so on consider accordingly
13. The contractor offers their rates on above / below percentage as per items rates of BOQ will be considered in biding competition.
14. The work will be started immediately after issuing work order & signing agreement. In case of absence of the contractor for non-starting of work, the contract will be cancelled and his security / earnest money will be forfeited to the Government.
15. All relevant taxes will be deducted from the contractor bills as per Government/KPPRA Rules.
16. In case of bid/rate quoted by the bidder more than 10% below Engineer's estimate, the additional bid security shall be sought from the bidder only to the extent of bid more than 10% below the Engineer's estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below Engineer's estimate. The percentage of bid security shall be 2% of the Engineer's Estimate.
17. Tender documents of bidder if found bogus / false, documents will be rejected and their registration will stand cancelled / blacklisted in addition of forfeiture of Earnest Money.
18. Single-stage-one envelope bidding procedure containing envelop marked financial Proposal alongwith all connected documents specified in KPPRA Rules 2014 shall be followed for receiving and processing the bids.
19. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
