In accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules 2014, the Directorate of Works & Implementation, Sports and Youth Affairs Department, Government of Khyber Pakhtunkhwa, hereby invites Electronic Bids from eligible firms/bidders through the E-Pak Acquisition and Disposal System (E-PADS) online bidding system for the following work(s) under the Single Stage – Two Envelope Procedure:

- The bidder must possess active and valid registration with Pakistan Engineering Council (PEC) in the relevant category, Khyber Pakhtunkhwa Revenue Authority (KPR), and must be on Active Taxpayer List (ATL).
- Technical evaluation will be carried out as per the criteria defined in the bid solicitation documents.
- All bids must be accompanied by a Bid Security @ **2%** of the engineer's estimate along with additional security, if applicable as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22, in the name of Director (Works), Directorate of Works & Implementation Peshawar Khyber Pakhtunkhwa.
- The bid must also be accompanied by a separate non-refundable required Tender fee at the prevailing rates (0.03% of the estimated cost) in shape of Demand Draft / Deposit at Call or Pay Order favouring Director Works to be issued by a scheduled bank.

5. Bids must be submitted through the E-Pak Acquisition and Disposal System (E-PADS) portal (kp.eprocure.gov.pk) on or before as per relevant work submission last date and time.
6. The procurement shall be processed under the single stage – two envelope procedure under Rule 12(2)(b) of the KPPRA Rules, 2014.
7. The bidders are required to quote their rates (electronically) "ABOVE/BELOW/AT PAR" for both priced BOQ/Engineer Estimate based on **MRS-2025** and NSI items as well. Only two digits after the decimal point shall be considered for evaluation purpose.
8. All other items not mentioned in the BOQ but exist in the **MRS-2025** shall be paid to the contractor's rate approved by the competent authority with approved area cost factor.
9. The bidding process will be carried out as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22.
10. The notification S.R.O No. (15)/Vol: 1-25/2022-23 amended vide notification No S.R.O (18)/Vol:1-28/2023-24 will also be applicable.
11. The successful bidder shall sign the formal Contract Agreement within the stipulated time; failure shall result in cancellation of award, forfeiture of bid security, and further action under KPPRA Rules.
12. All the information and documents provided by the bidder must be based on facts beyond any doubt. During analysis / Scrutiny or evaluation of the proposals any misrepresentation, false statement or fake document would make a ground for rejection of the bid and will also be liable for debarment / blacklisting. Any fake document or misrepresentation detected during the currency of the contract, will render the firm to be black listed and would be reported to the PEC for cancellation of their registration/license.
13. The bidder shall provide no litigation certificate with the procuring entity.
14. Bids will be valid for a period of ninety (**90**) days.
15. Incase evaluated bids of two or more than two bidders are the same then the successful bid will be declared through open draw.
16. All prevailing rules of KPPRA issued from time to time shall be observed during the procurement process.
17. Bid securities of 1st, 2nd and 3rd most competitive bidders will be retained by the procuring entity till the approval of bids.
18. In the event that any of the deadlines given for bid submission falls on a public holiday, the activity will be carried out on the following working day.
19. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
20. The bidder must have successfully completed at least TWO (02) building of RCC framed structures (minimum G+1 / two storey) during the last FIVE (05) years, each having a value not less than 70% of the Engineer's Estimated Cost
21. Joint Venture (JV), will not be accepted.
22. The bidder must demonstrate ownership / lease agreement of key construction equipment (excavator, roller, compactor, concrete mixer, etc).
23. The Bid security must reach the office of the undersigned on or before the due date.
24. The bidder must submit an undertaking on fresh stamp paper (E stamp) that firm is not involved in any kind of litigation with any department. Fresh affidavit (E stamp paper) to this effect that the firm/contractor have not been black listed previously by any executing agency Federal / Provincial Government department, KPPRA, or PEC during the last FIVE (05) years.
25. Due to the scattered geographical location of the sites and in order to ensure effective mobilization, quality control, and timely completion of works, a bidder shall be allowed to submit bid for more than one site; however, only ONE (01) site shall be awarded to a single bidder. In case a bidder is found lowest evaluated for more than one site, the bidder shall be required to opt for any one site, and the remaining site(s) shall be offered to the next lowest evaluated responsive bidder(s) in accordance with KPPRA Rules.
