1. The firms/Contractors shall submit bids through <http://eprocure.gov.pk>
2. Tender form/BOQ/BSDs can be downloaded from the official EPADS website i.e. (eprocure.gov.pk) after publishing NIT in newspaper and KPPRA Website. The BD will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
3. The bid security, additional security and detail rate analysis (if quoted rate in more than 20% below on the Engineer estimate) shall be submitted as per KPPRA Notification No.S.R.O (14)//Vol:1-24/2021-22/6058-71 dated 10/05/2022 along with the bid in sealed envelop before closing date and time to the office of undersigned.
4. Non-refundable bidding entry fee @ Rs.0.03% of estimate Cost in the shape of call deposit shall be submitted along with bid.
5. According to KPPRA Rules the contractors must be registered with KP Revenue authority with active status.
6. Technical evaluation will be carried out on marks threshold in passing all the fields including PEC Registration, Enlistment with LCB, Tax Payer proof, Relevant experience in past 05 years, Performance, Technical Personnel, required Equipment, Financial status, Auditors report, Managerial capabilities, Litigation status etc.
7. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
8. Any bidder who provides incorrect information, fake documents should be disqualified.
9. Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
