through EPADS (E-Pak Acquisition & Disposal System)**

Dean, MTI Bacha Khan Medical College (BKMC) Mardan, invites sealed bids from the Eligible Contractors registered with Pakistan Engineering Council (PEC) with codes CE-09, CE-11(ix), EE-11(vi) in Category C-6 or above for "**Annual Maintenance & Repair Works**" at MTI BKMC and its allied colleges. The bidding procedure will be conducted in light of 6 (2) (a) "**Single Stage One Envelope Procedure**" of KPPRA Rules 2014.

The bidding process will be carried out under the **Framework Contract** procedure as prescribed in Rule 31-A of the KPPRA Rules, 2014 and extendable up-to maximum 03 years.

The interested bidders shall submit bid (s) by uploading scan copy of bid(s) **on EPADS** on or before **19-02-2026**, which shall be opened on the same date at **02:30 PM** in Conference Room of the Administration Block of the Institute. The bidders shall upload all the mandatory and relevant documents alongwith the bid security on the EPADS.

Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.

The bidders are required to submit bid security **Rs.200,000/-** (in original) and physical in the form of Call Deposit Receipt (CDR) / Demand Draft (DD) / Pay Order or Banker's cheque in the name of "DEAN MTI-BKMC Mardan".

- i. The bidders should be registered with FBR and reflected on Active Tax Payer list (ATL).
- ii. All the bidders should also be registered with KP Revenue Authority (KPRA).
