

E-TENDER NOTICE (EPADS)

Office of the undersigned invites sealed quotations under single stage single envelop procedure from registered firms/suppliers for the purchase of Office furniture, Electronic Equipments, Solarization and other services for Directorate of Outreach Agriculture Research Peshawar under ADP scheme.

General Term & Conditions

1. The interested and eligible bidders/contractors duly registered on EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> are eligible to apply under single stage single-envelope method of KPPRA Rules. The E-bid must be submitted/uploaded through EPADS on or before 16 Feb, 2026 at 11:00AM. The bids on EPADS (e-bidding) shall be opened on the same day at 11:30 AM.
2. Tender will be processed through EPAD; bidders are requested to upload quotations accordingly.
3. Only BSD-coded items shall be included in the quotation; additional/non-coded items will not be entertained.
4. Bidder must mention the quoted item name, brand, and complete specifications.
5. For clarification regarding specifications, size, quality, or other queries, bidders may visit the office during working hours up to the submission deadline.
6. Firm must be registered with FBR (Sales Tax and Income Tax) and KPRA (Only for Services); all required documents must be attached at submission, otherwise the quotation will be rejected.
7. Prices must be quoted in PKR and include all applicable taxes; if not stated, prices will be deemed inclusive of all taxes.
8. Selection will be carried out on a lot-wise basis, based on the total quoted value for each lot.
9. The lowest financial bid (lot wise) will be considered, provided the offer fully complies with the required technical specifications and quality standards. The lowest rate shall not be construed as acceptance of substandard material, equipment, or workmanship
10. Competent authority may reject any or all bids by assigning reason under Clause 47 of KP Public Procurement Rules, 2014.
11. Payment will be made after successful/complete supply, installation, and inspection of all requisite items, subject to availability of government budget.
12. Firms are bound to accept government/KPPRA terms and any further conditions introduced during the contract period, in addition to tender terms.
13. Security call deposit (CDR) of 2% of total bid value of the total quoted amount must be submitted with the bid.
14. An affidavit on judicial stamp paper must be annexed with bid with declaration that the owner of the firm and the firm is not black listed by any of the government or other organizations. Without this affidavit the quotation will be rejected.
15. Rates should be inclusive of all applicable taxes and valid upto June 30, 2026 and delivered to site mentioned in tender documents. Any change in duties, price hike due to any reason will be on part of supplier.
16. All general and special terms and conditions, clauses, rules, regulations, and provisions in the BSD apply to all participating firms/suppliers/sole distributors/manufacturers
