- Contractors will quote their rates electronically and BOQ can be downloaded from PHED website www.phedkp.gov.pk prior to closing date & time.
- Instructions to bidders and any other information may be obtained from the office of the undersigned prior to closing date of bid submission on any working day.
- All bidders/contractor must have registration with KPRA, otherwise bid will be non-responsive
- The contractors quoting their bids upto 10% below Engineer Estimate shall submit bid security 2% only of Engineer Estimate. The contractor quoting their rate more than 10% below & up to 20 % below of Engineer Estimate shall submit along with their bids 8% additional security of Engineer Estimated cost in addition to 2% bid security .If the bid is not accompanied with required amount of additional security then bid will be considered non-responsive and 2% bid security shall forfeited in favour of Government and 2nd lowest bidder and so on will be considered accordingly
- The contractors quoting bid more than 20% below shall submit an additional security on Engineer Estimated cost equal to the differential amount Engineer Estimate and submitted bid (Differential amount :i.e if a contractor quote 25 % below then he will submit 25% additional security of Engineer Estimate in addition to 2% bid security) along with detail rate analysis.
- In case of more than 20% below bids, if the bid is not accompanied by detail rate analysis and/or required additional security the bid shall considered non-responsive and all other securities with such non-responsive bid shall be forfeited in favour of Government and 2nd lowest bidder and so on will be considered accordingly, In case detail rate analysis submitted with bids is in view of procuring entity not convincing then Head of procuring entity may declare such bid non-responsive without any forfeiture of bid securities and record reason thereof.
- Bidding/Tender documents must reach to the office of Executive Engineer PHE Division Bannu on or before dated **20/02/2026 at 1200 Hours**, which will be opened on the same day at **1400 Hours**.
- The competent authority reserved the right to reject any or all bids by assigning cogent reason.
- All others terms & condition will be as per KPPRA Rules notified time by time
- CDR will not be released till completion of tender process.
- In case tender submission and opening date is notified / declared as a public holiday then next working day will be tender submission and opening date.
- The Tender Fee submitted with documents in shape of call deposit which will not be released, if the Tender Fee not attached with the documents will be considered as non-responsive.
