TERMS & CONDITIONS


1. The bidder shall submit/upload the bids [by file uploading] through EPADS before last date and time for submission of bid.
2. Bid Solicitation Documents can be download from EPADS website before closing date and time.
3. The Bidders shall submit their bids through EPADS as well as submit a hard copy in a sealed envelope. The hard copy of the bid must be sent to the office of the Executive Engineer, PHE Division, Kurram, through registered courier service before the bid submission due Date/time.
4. The bidder quoting their bids more than 10% below up to 20% below on Engineers Estimates shall submit along with their bids 08% additional security of Engineer's estimated cost in addition to 2% security.
5. The Bid Security (in original), Additional Security (in original) and detail rate analysis shall be submit as per KPPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058- 71 dated Peshawar, 10/05/2022. In case of any bidder quoting below than 20% on Engineer's Estimated Cost, uploading (on EPADS) of Rate Analysis with the required Additional Security is mandatory. In case of non-convincing rate analysis, the bid shall be rejected and the next lowest bidder shall be considered for award of contract.
6. Non-refundable bidding entry fee @ 0.03% of the estimated cost shall be submitted with bids in the shape of call deposit (in original) in the name of the Executive Engineer PHE Division

Kurram.

7. The bid must remain valid for 90 days from the date of opening.
8. The bid security shall be in the form of a Call Deposit in favor of the **Executive Engineer, PHE Division, Kurram.**
9. All the bid securities i.e. submitted CDRs for the advertised work shall not be released to any contractor before awarding of the contract as per KPPRA Notification S.R.O (29)/Vol: 1-40/2025-26 dated 29th Oct, 2025.
10. Any cutting / overwriting on the tender form/BOQ shall be liable to rejection of the tenders and will be declared as non-responsive.
11. The competent authority reserves the right to accept or reject any or all bids under **Rule 47 of KPPRA Rules, 2014.**
12. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
