3. A Pre-bid Meeting will be held on 10th February 2026 at 11:30 AM at the WSSCK Office at the address given below. The bidder/ bidders shall upload their queries on EPADS prior to pre-bid meeting to resolve their queries.
4. All bids must be accompanied 2% Bid Security in favor of Water and Sanitation Services Kohat. An affidavit is mandatory in technical bid to the effect that bid security is placed in the financial bid.
5. Each envelope must contain separate Technical and Financial bids, clearly marked in bold and legible letters. Bids must be uploaded on the EPADS software, and a sealed hard copy of the documents, as required under the technical criteria, must be submitted complete in all respects must reach the office of the undersigned on or before **20th February 2026 at 11:00 AM**. The technical bid will be opened on the same day at **11:30 AM** in the presence of the Procurement Committee and the bidders or their authorized representatives.
6. Any bidder who fails to upload their bid on the e-procurement software (EPADS) and submits only a sealed bid will be considered non-responsive, and their bid will not be entertained.

8. All federal and provincial duties/stamp duty/taxes including sales tax will be recoverable as per directives of the government issued from time to time.
