### TERMS & CONDITIONS

1. Bid Solicitation / Bidding Documents can be downloaded from the EPADS website i.e. ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and KP-PPRA website ([www.kppra.gov.pk](http://www.kppra.gov.pk)).
2. The eligible contractors / firms are required to submit their Bids through EPADS as well as also send their bid in hard and sealed envelopes i.e. one envelope containing "Technical Proposals" and clearly marked as "Technical Bid" accompanied, while the second envelope containing financial proposals clearly marked as "Financial Proposal". Both Technical and Financial proposals / bids will be placed in a single sealed envelope and addressed and sent to the Office of Tehsil Municipal Administration Bara District Khyber through registered courier service before bid submission due time.
3. The securities shall be in shape of call deposit in favor of the TMO, TMA Bara District Khyber.
4. The last date and time of submission of electronic tender form is 23rd February, 2026 at 12:30 PM. The date and time of Opening of Financial Bid shall be announced after evaluation of technical bids.
5. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
6. Cutting / overwriting in the bid solicitation documents will not be acceptable. Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into disqualification and the same contractor will be considered as non-responsive.
7. The "Technical Proposals / Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Documents.
8. The "Financial Bids / Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
9. Matters related to Bid Security and Additional Security shall be dealt in accordance with KPPRA Notification No. S R O (29)/Vol 1-40/2025-26 dated 29<sup>th</sup> October, 2025 and matters pertaining to additional Security shall be in accordance with Notification No. S R O (14)/Vol: 1-24 2021-22 dated 10<sup>th</sup> May, 2022.

10. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing time of the bid.
11. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss.
12. Bids will remain valid for 90 days from the closing date of bids.
13. The firms / contractors who want to participate in tendering process may register themselves with the EPADS for gaining their unique username and password
14. Period of Completion will be based on Work Order(s).
15. Any condition/instructions, if missing, will be dealt in light of the KPPRA rules.
16. Contractors whose past performance is not satisfactory with this Office shall be considered as non-responsive.
17. All those contractors who are willing to apply in Tirah Works, shall obtain NOC from the Inspector General Frontier Corps (North) Office or Headquarter 27 Brigade Operational Area (Khyber Tribal District) certifying that the said contractor is permitted to execute the works in the concerned area. In case of non-availability of the same, the bidder shall be considered non-responsive.

Furthermore, all others terms & conditions / regulation notified by the KPPRA vide notification No. S.R.O(14)/Vol:1-24/2021-22 dated 10-05-2022/6058-71 in letter and spirit.
