The interested and eligible bidders/contractors duly registered on EPAD link <https://kp.eprocure.gov.pk/#/supplier/registration> are eligible to apply under Single stage two-envelope method of KPPRA Rules. The E-bid must be submitted/uploaded through EPADS on or before March 12, 2026 till 11:00 am. The technical bids on EPADS (e-bidding) shall be opened on the same day at 11:30 am.
2. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted / responsive bidders shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through the provided email address.
3. ORIGINAL two (2%) CDR of the bid price in the name of "Conservator of Forests FP&MC Peshawar" (Separate for each package) and an affidavit regarding original 02% CDR shall be separately sealed and put in separate envelopes and marked as such. The envelopes containing the ORIGINAL CDR and an affidavit regarding 02% CDR will be put in one large sealed envelope and shall reach on below given address before the closing date and time.
4. All applicable taxes including Sales tax, Income tax, KPRA taxes, stamp duties etc. as per Government Rules enforced shall be applicable.
5. All the rates shall be quoted on (FOR) basis with free supply / delivery to FP & MC office Peshawar.
