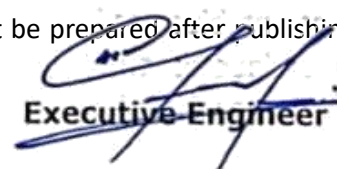

- Each bidder must attach photocopies of CNIC, PEC Registration Certificate (valid), Enlistment Certificate and Active Taxpayer of FBR and KPRA with each work bidding document.
- Bid Solicitation / Bidding Document can be downloaded from the EPADS website (i.e www.eprocure.gov.pk) and KP-PPRA website (www.kppra.gov.pk)
- The eligible contractors/firms are required to submit their bids through EPADS as well as also send their bid in hard and sealed envelope. The bids should be sent to the Executive Engineer PHE Division Orakzai through registered courier service before bid submission due time.
- The last date and time of submission of electronic tender form is 05.03.2026, 12:00 PM.
- The date and time of opening is 05.03.2026, 12:30 PM.
- The contractors quoting their bids more than 10% below upto 20% below on Engineers Estimates shall submit alongwith their bids 08% addl: security of Engineer's estimated cost in addition to 2% security, if the bid is not accompanied with their required amount of addl: security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Govt: and the 2nd lowest bidder and so on will be considered accordingly.
- Detail rate analysis shall be submitted as KPPRA Notification No SRO (14)/Vol: 1-24/2021-22/ 6058-71 Dated: 10.05.2022.
- Cutting/Overwriting in the bid solicitation documents will not be acceptable. Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into disqualification and the same contractor will be considered as non-responsive.

- In the case of violation for second time, blacklist him for a minimum period of three (03) years in accordance with section 29 of the KPPRA Act read with Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014
- Matters related to bid security and Addl: security shall be dealt in accordance with KPRA Notification No: SRO (29)/Vol:1-40/2025-26 dt: 29.10.2025.

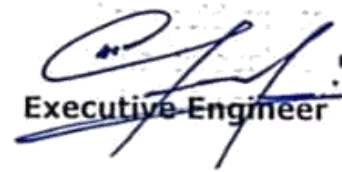

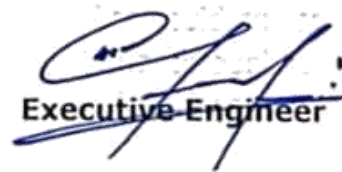
