2. Any tender or offer of works made by any enlisted contractor without filling Bids online shall be null and void henceforth.
3. The Bid Security and Additional Security shall be submitted as per KPPRA Notification No.S.R.O(14)/vol: 1-24/2021-22/6058-71 dated 10-05-2022.

As per KPPRA Notification No. S.R.O (29)/Vol: 1-40/2025-26/699-711 dated 29/10/2025, bidders are required to enter detail of bid security and additional security in EPADS and the same shall be submitted to the procuring entity well before closing time and date and the same will be retained by the procuring entity until the award of contract or bid validity whichever come first. Failure to do so action will be carried out as per the mentioned notification.

Bid documents, including original bid securities of estimated cost and detailed rate analysis (if applicable), must be submitted in a sealed envelope via courier to the TMO Office, TMA Bahrain at Panjigram Bahrain, before the bid closing time.
