


INVITING E-PADS TENDER NOTICE

2. All bidders/ contractors must have registration with Khyber Pakhtunkhwa Revenue Authority (KPRA) and PEC with active status and having codes i.e **CE-09 for civil** otherwise his bid will be considered non-responsive.
3. Last Date & Time of Submission of the bid is **10-03-2026** at 11:00 PM and will be opened on the same day at 12:00 PM in the presence of the contractors or their authorized representative who opt to be present.
4. The Bid Security (in original), Additional Security (in original), and detail rate analysis shall be submitted as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022, along with the bidding documents in a sealed envelope before the designated closing time of the Bid submission to the office of the undersigned.
5. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted/furnished with bids in the shape of separate call deposit (in original) in the name of the Executive Engineer.
6. The Competent Authority reserves the right to reject any or all the bids as per the provision contained in rule 47 of KPPRA Rules 2014.
7. Bidders who fail to meet the specified conditions or submit incomplete documents in any aspect shall be liable to rejection.
