

**TENDER NOTICE FOR TRANSPORTATION OF WHEATS/GOODS UNDER THE HEAD A03806-001 FOR THE 4<sup>th</sup> QUARTER FOR THE FINANCIAL YEAR 2025-26.**

Sealed bids for the transportation of Wheat/goods under the head A-03806-001 from Passco Punjab to Provincial Reserve Centres (PRCs) at Peshawar, Nowshera, Charsadda, Mardan, Swabi, Dargai/Sakhakot, Dir Lower/Tarai, Dir Upper/Warai, Swat, Buner, Shangla, Haripur, Havelian, Kohistan Upper/Lower, Mansehra, Battagram, Tank, Kohat, Hangu, Bannu, Krapa/ Rahmatabad (Karak), S.Naurang (Lakki Marwat), D.I.Khan, Kurram (Shah Flour Mill), South Waziristan Upper and Lower and NRC Azakhel for the 4<sup>th</sup> quarter for the Financial year 2025-26 are invited from registered A-Class Carriage Contractors / Firms.

2. **DETAIL OF TERMS AND CONDITIONS ARE GIVEN AS UNDER: -**

- i) The rates shall be quoted per ton per kilometre (net weight) in Pak Rupees, both in words and figures, for transportation of wheat/Goods from various districts of Punjab (PASSCO Zones) to the Provincial Reserve Centres (PRCs) in Khyber Pakhtunkhwa, strictly in accordance with the approved Distance Chart of the Food Department.
- ii) Bid Security in the shape of irrevocable CDR/SDR amounting to Rs. 5,000,000/- (Rupees Five Million only) from any scheduled bank for each PRC and NRC shall be furnished in the name of the Director Food, Khyber Pakhtunkhwa, in original, at least 30 minutes prior to the opening of the tender on E-PADS. The Bid Security of the successful bidder shall be converted into Performance Security and shall remain valid till the expiry of the contractual period. (Cheques shall not be acceptable.)
- iii) Method of procurement shall be single stage single envelope.
- iv) Call deposit of the first lowest bidders will be retained till approval of rates / signing of the contract agreement after which the same amount will be converted in to performance security till the expiry of the contractual period. In case of refusal to sign an agreement, the earnest money will be forfeited in favour of the Provincial Government.
- v) In case of forfeiture of bid security of the first lowest bidder; the quoted rates of second lowest bidder will be analysed by the Rate Analysis Committee for consideration of offer for award of contract.
- vi) A Contractor / firm will not be allowed to offer rates for more than one Zone (as indicated in the tender form).
- vii) Each successful Contractor/Firm, will sign Contract Agreement within 15 (fifteen) days after approval of the rates offered. In case of failure, the call deposits shall stand forfeited in favour of the Provincial Government.
- viii) The successful Contractor/Firm shall have to provide 10% amount of the freight value of the allocated quantity in the name of Director Food, Khyber Pakhtunkhwa in shape of CDR/SDR, in case the 10% freight value exceeds the CDR/SDR of Rs. **5,000,000** (Five) million already pledged in the name of the Director Food in shape of performance security of the contractor, which will be refunded to the contractor after the completion of allocation.
- ix) The successful bidder shall be liable to pay Income Tax, KPRA Sales Tax on Services, Stamp Duty, DPR Fund, Professional Tax, and all other applicable Government taxes and duties at the prescribed rates notified by the Government from time to time. All such taxes shall be deducted at source by the Food Department. Any exemption, if admissible, may be claimed by the bidder from the relevant authority in accordance with the law.
- x) Any other information, if required, may be obtained from Food Directorate, Khyber Pakhtunkhwa, till one day before tendering.
- xi) The approved/Lowest firm carriage contractors will follow the directions/instructions of ICT Based intervention project of Food Department Khyber Pakhtunkhwa.
- xii) The competent authority may reject the tenders in part or in full on the basis of cogent ground/reasons.
- xiii) The proceedings during the tender opening shall be video recorded for transparency.
- xiv) Only those firms which are duly registered with the Food Department and have renewed their registration for the year 2025-26 shall be eligible to apply.
- xv) Tenders will be received on 11/03/2026 upto 10:30 AM on **E-Pads** and will be opened on the -same day at 11:00 AM at Food Directorate Khyber Pakhtunkhwa, Haji Camp Adda, GT Road, Peshawar City in presence of bidders / their authorized representatives and the Tender Opening Committee.
