1. Interested and eligible bidders/contractors should register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> before uploading their bids on EPADS till **Monday 16th March 2026** or before.
2. Bids must be submitted/uploaded through EPADS on or before **16th March 2026, till 10:30 am**. The bids of participating bidders submitted through EPADS (only) will be accepted and opened publicly on **16th March 2026 at 11:00 am**.
3. ORIGINAL two (2%) CDR / Additional security (If any) of the total bid price in the name of **“WSSP Contractor Securities”** and an affidavit regarding original 02% CDR / additional security shall be separately sealed in envelope and marked as **“CDR and Affidavit FOR Installation of WS Networks, Pipelines in Zone _____”**. The envelopes containing the ORIGINAL CDR and an affidavit regarding 02% CDR shall reach on below address before the closing date and time. **A separate CDR will be required for each package / Zone.**

The interested bidders should deposit a fee of PKR 3000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase-3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers.
