E-Bids, prepared in accordance to the instructions contained in the bidding documents along with bid security instrument, and required documents; must be submitted by using E-PADS on or before March 26, 2026 till 11:00 am. Manual bids shall not be accepted. Electronic Bids will be opened on the same day at 11:30 am.
2. Scanned copies of all documents shall be uploaded through E-PADS while submitting e-bid. However, bid security instrument in form of Call Deposit Receipt (in original) shall also be submitted in the office of the Medical Superintendent City Hospital Lakki Marwat, before closing time for submission of e-bid along with attested copies of other documents uploaded on E-PADS.
3. The approved rates will remain valid until June 30, 2026, under KPPRA Rule 31(A) pertaining to framework contracts/agreements.
4. Bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) for works/services.
5. The competent authority reserves the right to reject all bids or proposals at any time prior to the acceptance as provided under Rule 47 of the KPPRA Procurement Rules, 2014.
