2	Complete detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number and Date must be submitted electronically along-with E-Bid on E-Pak Acquisition & Disposal System (E-PADs)
3	The original bid security and additional security instruments of all bidders shall be retained until signing of the contract with the best evaluated bidder or till the bid validity period, whichever is earlier as per KPPRA notification No. S.R.O (29)/Vol.1-40/2025-26: dated 29.10.2025.
4	Complete set of Bid solicitation documents / criteria are available on the E-PAD System via <a href="https://kp.eprocure.gov.pk">https://kp.eprocure.gov.pk</a> and may also be obtained upon submission of a written application along-with photocopies of valid KPRA registration, PEC registration and C&W Enlistment renewal for the year 2025-26, up to 24-03-2026 from the office of the undersigned on cash payment (Non-Refundable) amounting to Rs. 8000/-for each.
5	Bidders with history of blacklisting from any Government / Private Organization will not be considered for qualification.
6	Valid NTN/GST Certificate as tax payer with FBR shall required.
7	A copy of the technical proposal in the required format is mandatory and to be uploaded as a part of E-Bid on EPAD before submitting Financial Bid.
8	Financial Bid will be opened after the approval of Technical Bids from competent Authority.
9	Pre-Bid meeting will be held on <b>16-03-2026 11.00</b> am at the office of undersigned.
10	Tender Entry Fee @ Rs.0.03% of the total Tender Cost shall be submitted in separate envelop in the shape of original CDR at the name of the Executive Engineer, Highway Division Dir Lower before opening of Tender. Failing which the bidder shall be considered as non-responsive.
11	Photo Copy of CDR, s OR 0.03% Tender E/Fee will not be accepted and shall be rejected.
12	Under Single Stage-Two Envelope Bidding Procedure, one envelope containing technical information of Bid shall be clearly marked "Technical Bid" and the second envelope containing the Bid Price shall be clearly marked "Financial Bid.
13	Bidders will be Technically Qualified on the basis of information provided with the Bids, as per the Criteria prescribed in the Bidding Documents. General experience, Personal Capabilities, Equipment Capabilities, Financial Soundness as well as Registration with PEC, KPRA, FBR, etc. shall be strictly calculated in the Technical Bids.
14	All the information and documents provided by the bidder must be based on facts beyond any doubt. During analysis / Scrutiny or evaluation of the proposals any misrepresentation, false statement or fake document would make a ground for rejection of the bid and will also be liable for debarment / blacklisting. Any fake document or misrepresentation detected during the currency of the contract, will render the firm to be black listed and would be reported to the PEC for cancellation of their registration/license.
15	In case bid becomes tie, the award of contract shall be decided through a free toss which shall be binding & final.
16	Venue of Bids Opening is in the office of the Executive Engineer C&W Highway Division Dir Lower.
17	Bids must reach this office through registered courier before closing time of bid submission. in case of failure of delivery of the envelope shall rest on the bidder/company who has used the relevant courier service. The labels of the Courier Service provider may be authenticated for tracking before opening. Fake Courier delivery shall be processed as per law and would not be considered.
18	The competent authority reserve the right to reject any or all the tenders by assigning the cogent reasons as per the provision contained in rule 47 of KPPRA Rules 2014.
