



TERMS AND CONDITIONS

- Last date & time for submission of Technical & Financial Proposals is 02.04.2026 at 12:00 (Noon) and the Technical Proposal will be opened on the same day at 12:30 PM.
- Bidding Solicitation Documents alongwith the bidding criteria and instruction to bidders and Terms & Conditions can be downloaded from official EPADS website and Irrigation Department website (www.irrigation.gkp.pk) as well as KPRRA website (kprra.gov.pk).
- Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the Technical Proposal, affirming that the CDR, attested copy of PEC registration, CNIC, NTN, and KPRRA Registration enclosed in the sealed financial bid is authentic and original. In case of non-availability of the Affidavit, the firm/bidder shall be considered as non-responsive.
- A copy of the Technical Proposal as well as Financial securities in the required format is mandatory and uploaded on EPAD System.
- For Additional Security in case of abnormally low bids KAPRA Notification S.R.O (14)/Vol:1- 24/2021-22, Dated: 10-05-2022 shall be enforced.
- Pre-bid meeting will be held on 24/03/2026 at 11:30 AM in the office of the undersigned.
- If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bid will be declared through draw.
- Bid will be valid for 90 Days.
- Separate Broacher/Technical Proposals for each work alongwith required documents shall be submitted clearly mentioning the scheme name. Hard copies of brochures must also be submitted to the office of the undersigned.
- The Financial Bid will be opened after the approval of Technical Bids from the Competent Authority.
- As per KPRRA Notification No. S.R.O (29)/Vol:1-40/2025-26/699-711, dated: 29.10.2025 clause (3): All bidders shall enter the details of the bid security and where applicable, the additional security instrument in the E-PAK Acquisition and Disposal System (EPADS) at the time of bid submission. The original bid security and additional security instruments, details of which have already been entered in EPADS, shall be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instruments of all bidders until signing of the contract with the best evaluated bidder or till the bid validity period whichever is earlier.
 - In case of failure to submit the original bid security and additional security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) year.
 - In the case of violation for second time, blacklist him for a minimum period of three (03) years in accordance with Section 29 of the KPRRA Act read with Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.
- All the prevailing KPRRA rules / Act and other Govt: notifications issued from time to time shall be applicable.
- Bid shall be accompanied with 0.03% of Estimated Cost as tender entry fee in a shape of separate CDR which is non-refundable. Non submission would lead to bid rejection.
