- 2) Bidders must submit a separate bid for each lot, and bids must be quoted accordingly.
- 3) Bid Security shall be 5% of the quoted value of each lot, in the shape of CDR/Bank Draft from a scheduled bank in favor of Project Director/Conservator Wildlife, Swat Mini Zoo. Bid security must be attached with the bid.



- 4) Bids must be submitted electronically through EPADs Khyber Pakhtunkhwa on or before 16/04/2026 at 11:00 AM.

In addition, hard copies of the bid along with the required documents including original CDRs must be submitted on the office address mentioned below before the closing time.

- 5) Bids will be opened on 16/04/2026 at 11:30 AM in the office of the undersigned in the presence of bidders or their authorized representatives, present at that time.
- 6) Bidders must provide:
- Copy of CNIC
 - Active FBR Registration (NTN)
 - Active KPRA Registration
 - Registration with any Wildlife Department in Pakistan
 - An affidavit that the firm is not blacklisted by any Government/Semi-Government organization on non-judicial stamp paper
- 7) The contract shall be awarded to the lowest evaluated responsive bidder for each lot, in accordance with KPPRA Rules.
- 8) Translocation, transportation, safe transfer, veterinary clearance, and a mandatory one-month quarantine period shall be the sole responsibility of the successful bidder.
- 9) The Competent Authority reserves the right to reject any or all bids at any time prior to acceptance of a bid, subject to relevant provisions of KPPRA Rules.
