6. All bidders are required to be registered with KPRA under Finance Act, 2013 Act No. XXI of 2013 and must be active tax payers.
7. Any bidder who provides incorrect information/document shall stand disqualified & his CDR will be forfeited.
8. The procuring authority reserves the right to reject any or all bids by assigning cogent reasons.
9. Pre-bid meeting will be held on 16-March 2026 at 11.00 A.M in office of the undersigned.
10. No pay order and Bank Draft will be acceptable except call deposit of scheduled Bank otherwise the bid will be declare as non-responsive.
