NOTICE INVITING TENDER THROUGH E-PADS

Sealed tender based on **MRS 2025 1st Bi-Annual** for below mentioned works are hereby invited on the basis of **Single stage single envelope procedure** from the Government Contractors enlisted with Director General LG & RDD Khyber Pakhtunkhwa, registered with PEC enlisted with **C&W department** and WAPDA as per centralized enlistment policy of the government of Khyber Pakhtunkhwa for current financial year as per following schedule.

Terms & Conditions

- Bidding documents can be downloaded from the official EPADS website (www.portalkp.eprocure.gov.pk) after publication of the notice inviting tender (NIT).
- Contractor/firms/workshops registered or pre-qualified with WAPDA for the current financial year are eligible to participate in the tender.
- The filled bidding documents, bid security and enlistment documents (KPPRA registration, C&W registration, CNIC, PEC registration, WAPDA registration) and detailed rate analysis (if applicable)-complete in all respect- must be clearly scanned and uploaded online through **EPADS system**
- All contractors/firms registered with Inspectorate of Electricity Energy and Power Department Government of Khyber Pakhtunkhwa, under the electricity act 1937(Rule 48) holding a valid class-E license and providing 01-year warranty as per WAPDA SOPs, are eligible to participate in the tender.
- All eligible contractors/Firms must have Pakistan Engineering Council codes (EE-04 and EE-05).
- The original call deposit and detailed Rate analysis (if any) must be sent through courier to the **Office of the Assistant Director Senior LG&RDD Tehsil HQ, Haripur** before the bid closing time.
- Original call deposit and Rate analysis received through Fax or by hand shall not be accepted.
- Contractors/firms intending to participate in the Tendering process must registered themselves with EPADS to obtain a unique username and password.
- All registered contractors/Firms are required to download the Standard Bidding Documents (SBDs) from the official website and submit their bid strictly in accordance with the instructions provided therein.
- Any cutting, overwriting or manipulation in the tender form will not be accepted. Any mismatch between the scanned copies uploaded on EPADS and hard copies submitted will result in disqualification and such a bidder shall be treated as non-responsive.
- Rates must be quoted as a percentage above, below or at Par with engineer's estimate.
- The last date in time for seeking online clarification shall be up to 5:00 p.m. on 24th March, 2026.
- Bid security shall be in the form of a call deposit in favor of the **Assistant Director Senior Local Government and Rural Development Department district Haripur.**
- As per KPPRA Notification no S.R.O. (14)/Vol: 1-24/2021-22: Dated May 10, 2022: The contractors quoting their bids up to a limit of **10% below** Engineer estimate shall submit **bid security @ 2%** only of Engineer Estimate.
- The contractors quoting their bids more than **10% below** up to **20% below** on Engineers' Estimate shall submit along with their bids **8% Additional Security** of Engineer's Estimated cost in addition to **2% bid security**. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- [Similarly, a contractor quoting bid **more than 20% below** shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers'

Estimate along with detailed rate analysis]1. In case of more than **20% below** bids, if the bid is not accompanied by the detailed **rate analysis** and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.

17. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
18. The next lowest bidder and so on shall be considered regarding the as per **KPPRA notification No. 6058-71 Peshawar dated 10th may, 2022.**
19. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
20. Any electronic bidder who provide false, or materially inaccurate or incomplete information, or does not send information/bidding Documents in hard form will be disqualified as per **KPPRA Act Section 29 (I) read with KPPRA Rule (43)**. Furthermore, the procuring entity/Executing Agency will recommend and send cases for **debaring /Blacklisting** and will initiate/take action in light of approved procedure/mechanism as per **KPPRA Act section 29(2) read with KPPRA rule (44)**.
21. Electronic Bids will remain valid for **90 days** from the closing date of bids.
22. The contractor shall bear all the expenses of the testing as well as vetting of the structure design from the government laboratories, registered structure engineers, as directed by the **Engineer LG&RDD Haripur** and will re execute works in case of failure without any payment.
23. Tender will be received till mentioned time on the opening date of tender and the tentative comparative statement downloaded from the website will be announced at the opening time, and final result will be announced after evaluation of bids in all respect in Bid validity time.
24. Call deposit of the other bidders will be retained till approval of the tender. Call deposit 2% and additional shall be present at the time of opening with the bids.
25. All bidders must be registered with the **Khyber Pakhtunkhwa Revenue Authority (KPRA)** under finance Act 2013 (**act No. XXI of 2013**).
26. The **PEC and KPRA** registration (Active tax payer) must be valid for current financial year.
27. The centralized Enlisted contractors with C&W department for the current financial year who wants to participate in tendering process may approach **Directorate General LG&RDD Peshawar** within **two days** before closing time of electronic apply for uploading their names on the official website i.e. (**www.lgkp.gov.pk**).
28. The contractor or his authorized representative maybe present at the time of opening of electronic bid.
29. Standard bidding documents for procurement of large works (more than 45 M) are applicable and can be obtained from this office and is available/ can be downloaded from **KPPRA website**.
30. Work orders will be issued as per the KPPRA notification regarding Technical Sanction and release of funds.
31. The Procuring entity reserves the rights to reject any or all bids by communicating valid reason for rejection at any time prior to award of the contract.
32. All applicable taxes will be recoverable as per directives of the government in vogue.
33. The successful bidder/contractor shall be responsible for producing a **satisfactory completion certificate** from the **concerned MPA** and the **Technical Committee** constituted for the purpose before submission of the all bill for payment.
