- Bid Solicitation Documents can be downloaded from EPADS website (<https://kp.eprocure.gov.pk>) or can be obtained from the undersigned office on any working day before the bid submission last date/time.
- The bidder should submit their E-bids as per KPPRA Notification No. S.O.R. (14)/Vol: 1-24/2021-22 dated 10/05/2022.
- A copy of technical proposal in the required format is mandatory to be uploaded as a part of E-bid before submitting Financial Bid, Scanned copy of bid security shall be submitted electronically along with Technical Bid on E-PADS system.
- Original copies of Call Deposit of Bid Security/Additional Security and Bidding Entry Fee Shall reach to the undersigned office before closing date/time.
- An Affidavit/Certificate by the bidder shall be submitted to the office, stating that Original Bid Security and additional security has been placed in the financial proposal without indicating the figure. In case of failure, the bid shall be considered as Non-Responsive.
- In case of failure to submit the original bid security and additional security instrument before the date and time, the bidder shall be debarred for a period of one year. In case of violation for second time, the bidder shall be blacklisted for a minimum period of three (03) years in accordance with Section 29 of the KPPRA Act read Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014. All the bid securities i-e submitted CDRs for the advertised work will not be released to any contractor before awarding the contract as per KPPRA Notification S.R.O.(29)/Vol: 1-40/2025-26 dated October 29, 2025/699-711.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, under Finance Act No. XXI of 2013 and must be active tax payer.
- Rates may be offered as % above, % below or At Par on Engineer's Estimate.

9. The instruction issued by KPPRA vide Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10/05/2022 will be applicable.
10. Any Electronic Bidder who provides incorrect/incomplete information shall stand Non-Responsive.
11. Bids will remain valid for 90 days from the closing date of the bids.
12. The procuring entity has the authority to reject a bid or all the bids assigning cogent reason(s) under Rule-47 and go ahead for Re-bidding under Rule-48 of KPPRA Rules 2014.
