



Terms & Conditions.

- 1 The Firm/Contractor should be registered with Income Tax and Sales Tax Departments and be on the Active Taxpayers List of the Federal Board of Revenue and have a registered office, for the above developmental Schemes.
- 2 The bids, prepared in accordance with the instructions in the bidding documents, must be submitted on EPADS up to at 12:00 PM. Bids will be opened on the same day at 12:30 PM.
- 3 Tender will be based on (MRS-2025 1st Bi-Annual) and contractors/Firms should quote their rate on a percentage above/below/at-par Basis.
- 4 All the contractors / Firms are bound to follow the KPPRA rules.
- 5 All the contractors / Firms must be registered with the Khyber Pakhtunkhwa Revenue Authority and EPADS.
- 6 The following documents shall be attached to the bids. (i) Copy of enlistment with PEC and Local Council Board, Khyber Pakhtunkhwa, Peshawar, for the year 2025-26. (ii) Photocopy of CNIC. (iii) Power of Attorney (if applicable). (iv) NTN/Income tax certificate and KPRA Registration. (v) tender form/BOQ/BSDs.
- 7 Bidding documents, containing detailed terms and conditions, can be downloaded from <https://eprocure.gov.pk> free of cost.
- 8 Bids should be submitted electronically ONLY through EPADS. Manual submission of bids is NOT allowed. For registration and training on EPADS or in case of any technical difficulty in using EPADS, prospective bidders may contact the Tehsil officer (I & S) office, Tehsil Municipal Administration Batkhela, during office hours.
- 9 The Electrical Works must be vetted by the Assistant Engineer (Electrical) Local Council Board, Khyber Pakhtunkhwa, Peshawar, before the execution of the works.
- 10 The Bid Security and additional security shall be submitted as per the KPPRA notification No. S.R.O. (14)/Vol: 1-24/2021-22/6058-71 dated 10 May 2022.
- 11 Tender documents of the bidder, if found with bogus/false documents, will be rejected, and their registration shall stand cancelled/blacklisted, in addition to forfeiture of earnest money.
- 12 The contractors/firms will have to start work immediately after the issuance of work orders; otherwise, their call deposits will be forfeited, and they will not be allowed to participate in any tendering process.
- 13 All Pages of the tender/bid documents shall be initiated, and the official seal shall be affixed by the person or persons signing the bid.
- 14 Cutting/Overwriting/manipulation in Bid Solicitation Documents will not be acceptable. Any mismatch in scanned copies uploaded on EPADS and those submitted in hard copy will lead to disqualification, and the same will be treated as non-responsive.
- 15 Original tender documents should reach the office of Tehsil Municipal Administration Batkhela before the due date and time.
- 16 No tender is acceptable through Fax/by hand.
- 17 Complete details of Bid Security in the shape of CDR, i.e., Bank Name, CDR Number(s), and Date(s) must be submitted electronically on EPADS and provided in hard copy to this office.
- 18 The venue of the bid opening is the office of the Tehsil Municipal Administration Batkhela.
- 19 In case the opening date of the tender is announced by the Government. It is a holiday, then the tender will be opened on the next working day.
- 20 In case of a tie between bidders, the successful bidder will be decided through a Draw.
