

**Terms and Conditions:**

1. Bid Solicitation/Bidding Documents can be downloaded from the EPADS website i.e. ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and KP-PPRA website ([www.kppra.gov.pk](http://www.kppra.gov.pk)).
2. The eligible contractors / firms are required to submit their Bids through EPADS as well as also send their bid in hard and sealed envelopes i.e. one envelope containing "**Technical Proposals**" and clearly marked as "**Technical Bid**" accompanied, while the second envelope containing Financial proposals clearly marked as "**Financial Proposal**". Both Technical and Financial proposals/ bids will be placed in a single sealed envelope and addressed and sent to the **Assistant Director (Senior) LG&RDD Headquarter District Lakki Marwat** through registered courier service before bid submission due time.
3. The last date and time of submission of electronic tender form is **31<sup>st</sup> March, 2026 at 12:30 PM**. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
4. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
5. Cutting/over writing in the bid solicitation documents will not be acceptable. Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into disqualification and the same contractor will be considered as non-responsive.
6. The "Technical Proposals /Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Documents.
7. The "Financial Bids / Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
8. The securities shall be in shape of call deposit in favor of the **Assistant Director (Senior) LG&RDD District Lakki Marwat** Matters related to Bid Security and Additional Security shall be dealt in accordance with KPPRA Notification No. S.R.O.(29)/Vol:1-40/2025-26 dated 29th


October, 2025 and matters pertaining to additional Security shall be in accordance with Notification No.S.R.O.(14)/Vol: 1-24/2021-22 dated 10th May, 2022.

9. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing time of the bid.
10. The last time and date for online clarification is up-to 05:00 PM on 25-03-2026.
11. Financial Soundness if necessary by PE provided through bank statement, which will be verified.
12. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss.
13. Bids will remain valid for 90 days from the closing date of bids.
14. The firms/contractors who want to participate in tendering process may register themselves with the EPADS for gaining their unique username and password.
15. The PEC and KPRA registration (Active Tax Payer) must be valid for current financial year.
16. The Eligible bidder must have the relevant codes for the above mentioned works as per Pakistan Engineering Council (PEC).
17. All material testing and all sorts of tests will be performed by contractor on the demand of the procuring entity.
18. The Procuring Entity may reject all bids or proposals at any time prior to the acceptance of bids or proposals in light of KPPRA Rule No.47.
19. Bid security of all electric bidder for the work will be retained by the department till the approval of bids.
20. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
