4. The bidders may obtain further information, inspect, and acquire the Bidding Documents from the office of the Employer at the address given below during working hours, or download them from e-PADS upon submission of a written application.
5. The bidders must submit their bids through the E-PAK Acquisition and Disposal System (EPADS), on or before **March 27, 2026**, by 1100 Hrs. In addition, sealed hard copy of the bid shall be delivered to the address below not later than the bid submission deadline mentioned above. Bids not submitted through EPADS, will be declared non-responsive and will not be considered for evaluation. Submission of hard copy is required solely for evaluation purposes. In the event of any discrepancy or ambiguity between the hard copy and the electronic submission, the bid uploaded on EPADS shall prevail.
6. The bids will be opened on the same day at 1130 Hrs in the presence of the bidders' authorized representatives, who choose to attend.
7. The bids must be accompanied by a bid security @ 2% of the total bid/ quoted price in Pak Rupees in the shape of a bank draft/ CDR in favor of "CEO, PEDO", valid for 28 days beyond the bid validity date.
