Terms and Conditions:

1. Work-wise Bid Solicitation Documents (BSD), which includes Bidding/Contract Data, Bill of Quantity (BOQ), Criteria for (i) Basic Eligibility/Mandatory, (ii) Technical Bid Evaluation, (iii) Financial Bid Evaluation (iv) Award of Contract, and other criteria/data/information, can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before last date and time for submission of bid.
3. The bidder shall only submit, physically, their original bid security(ies)/additional security(ies) (in the shape of call deposit receipt made in favour of the undersigned) in the office of the undersigned before last date and time for bid submission.
4. The received technical bid(s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.
5. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
6. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive.
7. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.
8. The bidders shall submit their bids as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
9. KP-PPRA's Notification No. S.R.O.(29)/Vol:1-40/2025-26/699-711 dated 29/10/2025 shall be applicable.
10. Clarifications, if any, may be asked by the bidder through EPADS.
11. Incomplete / conditional bids with unattested cutting / overwriting / disfiguring shall be considered as "non-responsive".
12. The letter of acceptance shall be issued to the contractor after fulfillment of all codal formalities.
13. The bidder shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) with active status.
14. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
