The Tehsil Municipal Administration (TMA) Mardan invites bids electronically through EPADS (E-Pak Acquisition and Disposal System) on single stage single envelope procedure of KPPRA Rules 2014 from eligible firms / contractors registered with Pakistan Engineering Council in relevant category and enlisted with Local Council Board, Khyber Pakhtunkhwa, for the financial year 2025-26 on Specific field of specification for the following works.




Term & Conditions.

- The following shall be the eligibility criteria for Firm/Contractor and the firm supposed to provide the documentary evidence of the eligibility criterion:
 - The firm/contractor should be registered with Income Tax and Sales Tax Departments and must be on Active Taxpayers List of the Federal Board of Revenue & Khyber Pakhtunkhwa Revenue Authority.
 - Firm shall be enlisted with Local Council Board/Pakistan Engineering Council for the Financial Year 2025-26 in relevant category.
 - The firm/contractor should be registered with KPRA for the FY 2025-26.
 - The Firm/Contractor must have following specialized PEC Codes EE06, EE04, EE11(vv) in PEC Registration.
 - Any firm applying for a project must have an amount equal to 20% of the estimated cost available in its bank account at the time of application and shall provide attested copies of the bank statement as proof.
- The bids, prepared in accordance with the instructions in the bidding documents, must be submitted on EPADS Up to 07/04/2026 at 11:30 AM. Bids will be opened on the same day at 12:00 PM. In case the government declares a public holiday on bid submission date the next working day will be considered.
- The detail cost estimates are based on (MRS-2025 1st BI-Annual) and contractors/Firms should quote their rate (both figures/words) on percentage above/Below/at-par Basis.
- Only up to Two Decimal Digits (0.00) will be considered for evaluation of the quoted Bid. If any document submitted along with bid documents found false bogus, the registration of the Contractor /Firm shall stands cancelled blacklisted.
- All the contractors / Firms are bound to follow the KPPRA rules.
- The bidders shall also submit their Bids (Hard Copy) with requisite documents i-e: - E-Tender Form, Signed BOQ, Active NTN Income Tax Certificate, PEC, LCB & KPRA Registration (Active), 2% earnest money, additional security if any (original in shape of CDR) & a certificate to the effect that there is no dispute of the Firm with any department involved litigation/arbitration on the left over incomplete projects and blacklisting on Stamp paper to the office of the undersigned through Registered Courier Service before the closing time to the record branch of TMA Mardan. The Bids received by hand, not through Registered Courier Service and late shall not be entertained.
- Bidding documents, containing detailed terms and conditions, can be downloaded from <https://eprocure.gov.pk> free of cost.
- Bids should be submitted electrically through EPADS and manual submission of bids is mandatory before bid closing time. In case of deficiency of any document on EPADS or manual submission, the firm will be declared as non-responsive and action will be initiated as per KPPRA Rules.
- The Bid Security, additional security & Rate Analysis shall be submitted as per KPPRA notification No. S.R.O. (14)/Vol: 1-24/2021-22/6058-71 dated 10 May 2022.

10. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bids as Non-Responsive without any forfeiture of bid securities and record reason thereof.
11. Tender documents of bidder if found with bogus/false documents will be rejected and their registration shall stand cancelled/blacklisted in addition of forfeiture of earnest money.
12. The contractors/firms will have to start work immediately after the issuance of work orders, otherwise their call deposits will be forfeited and will not be allowed to participate in any tendering process.
13. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the person of persons signing the bid.
14. Cutting/Over writing/manipulation in Bid Solicitation Documents will not be acceptable. Any mismatching in scanned copies uploaded on EPADS and that submitted in hard will lead to disqualification and the same will be treated as non-responsive.
15. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically on EPADS and provided hard copy (original) to this office.
16. Venue of Bids opening is office of the Tehsil Municipal Administration Mardan.
17. In case of tie between bidders, successful bidder will be decided through Draw/toss.
18. The Scope of the work can be increase or decrease as per site requirements.
19. The procuring entity may reject all Bids or any proposal/ Bid at any time prior to acceptance of a bid or proposals. The procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection or of all bids or proposals as per Section 47(1) of KPPRA Rules 2014.
20. All the Government taxes (Federal, Provincial & any other) will be deducted as per prevailing Government policy.
21. Any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025 (Bi-Annual)/ prevailing market rates with the approval of the Competent Authority.
