The Schemes will be executed out of Local Fund TMA Gadezai.

**Terms & Conditions:**

1. Bidding documents along with tender form can be downloaded from official EPADS website after publishing NIT. The tender form will be filled neatly and a clean scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
2. While the original tender form along with original bid securities and detail rate analysis (if applicable), complete in all respect must be delivered through courier to the office of TMA Gadezai Buner before closing time of bid.
3. Cutting /Overwriting/Manipulation in the tender form will not be acceptable and any miss matching among the scanned copies submitted through EPADS and that submitted in hard will leads to disqualification and the same contractor will be considered Non-responsive.
4. The rates must be offered as percentages Above or Below or At Par on engineer estimate.
5. The last time and date for online clarification is upto 05:00 pm & date: 01/04/2026.
6. The bid securities shall be in the form of call deposits in the name of TMO TMA Gadezai.
7. The bidders shall have the relevant codes as per Pakistan Engineering Council against each mentioned work.
8. The earnest money and additional securities shall be paid in light of KPPRA Notification NO.S.R.O (14) VOL:1-24/2021-22 dated 10 May 2022 and Notification NO. S.R.O (29)/Vol: 1-40/2025-26 Vide Circulated No.699-711 Dated October 29, 2025.
9. In case of tie/draw amongst the responsive bidders, the bid may be decided through free toss, which shall be considered as final.
10. The firms/contractors who wants to participate in tendering process may register themselves in EPADS for their unique username and password.
11. Bids and original Call deposits received through FAX or by hand will not be acceptable. Sealed bids sent through registered mail/Courier service shall reach by the specified time and date as mentioned above

12. The original envelope Complete in all respect must be delivered through courier to the office of TMO TMA Gadezai. While the duplicate Copy may be delivered through courier to the office of Local Council Board Peshawar.
13. The contractor or his representative shall be present at the time of bid opening.
14. The call deposit i.e bid security for the work/contract must be prepared after publishing of NIT and before closing time of the bid submission.
15. The bidder shall submit their bids in Sealed Envelope within due time and date with requisite mandatory documents i.e Fresh Registration with LCB, Tender Form, BOQ duly signed and stamped, CNIC Copy, Active NTN/Income tax certificate, valid PEC License, and active KPRA registration.
16. The quoted rate must be clearly mentioned in words and in figures on tender form and no bidder shall be allowed to withdraw his bid after closing of bid time till award of the contract or till bid is valid, whichever is earlier.
17. Any bidder who provides false or materially inaccurate or incomplete bid will be disqualified as per KPPRA rules.
18. The rules & regulation/direction in future if any issued by provincial government or any competent authority shall be applicable.
19. If a holiday is declared by the government on the tender opening date, the tender will be opened on the next working day during office hours.
20. Work Order will be issued subject to the release of funds by the provincial Government. In case of non-release of funds, the tenders will be considered cancelled. The contractor will not be authorized to file/claim or challenge in any departments/courts.
21. Any additions made to the terms & conditions in the advertised NIT will be implemented as per KPPRA rules.
