Terms & Conditions for E-Bidding:-


- All bidders are requested to upload their Bids (CDR'S & Rate on BOQ / BID Documents along-with relevant documents in one PDF file) and submit through EPADS (<https://kp.eprocure.gov.pk/>) before the mentioned system closing time. Any bid received without uploading required documents i.e (copy of CNIC, Enlistment with Govt: of KP, Pakistan Engineering Council, Active KPPRA status & Active FBR status and rate analysis if required) will be treated as NON-RESPONSIVE. Incomplete/conditional bids with unattested cutting /overwriting/disfiguring uploaded shall be considered as NON-RESPONSIVE. No hard form / print out of bid are required / acceptable except CDR/call deposit. The Procuring Entity shall not be responsible for any technical fault, glitch, or error in the EPAD system and shall only consider the documents appearing on the EPAD dashboard. Therefore, all bidders are advised to upload the required documents carefully and responsibly.
- Electronic Bidding shall be done on "Above / Below System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
- The bidders should submit their E-Bids as per KPPRA Notification No. S.R.O (13)/Vol:1-24/2021-22/6058-71, dated: 10-05-2022 & notification No.S.R.O (29)/Vol:1-40/2025-26/699-711 dated 29.10.2025.
- The bidder shall submit the sealed envelope only including 2% Bid Security (or additional security if required) of the estimated cost in the shape of call deposit (original) before closing date and time.
- All the conditions / instructions given in the bidding documents shall be applicable on all competitive bidders.
- The bids will be valid for one hundred & twenty days (120) from the date of bids opening.

If same rates quoted by the contractors, the lowest bidder shall be decided through draw as per para-viii of notification vide Chief Engineer (North) Irrigation Deptt. 4/C-1/KPPRA dated 11.12.2025.

Deposit of Scheduled Banks shall be acceptable. Bank cheque OR pay order & (2%) in the shape of Bank guarantee shall not be acceptable.

Any Bidder who provides incorrect information or failed to submit the original bid security and additional security instruments before the date shall be liable to deal with under section 29 of the KPPRA Act read with rule 44 of 2014.

12. All the prevailing KPPRA rules / Act and other Government Notifications will be applicable issued from time to time & will become part of bidding documents.
13. Mandatory conditions as per solicitation bidding documents (SBDs) will be adhered.
14. The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
15. The work execution shall be payable as per MRS-2025 (1st B1-Annual).
