Terms & Conditions:

1. Bidding Documents along with Tender form can be downloaded from the official EPADS website i.e. (<https://portalkp.eprocure.gov.pk/>) after publishing NIT. The Tender form will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS and any information contact on email naurangtma@gmail.com of the TMA, Serai Naurang.
2. While the original Tender form along with original bid securities i.e. 2% earnest money and additional CDR (if applicable) and detail rate analysis (if applicable) complete in all respect must be delivered before closing hours through courier to the office of Tehsil Officer (I&S) TMA, Serai Naurang.
3. The last time and date for online clarification is upto (Time) on (date).
4. The bid securities shall be in the shape of call deposit receipt in favor of the TMO TMA, Serai Naurang.
5. In case detailed rate analysis submitted with the bids is in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeited.
6. The contractor or his representative can be present at the time of opening of bids.
7. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before closing time of the bid apply.
8. In case of tie draw amongst the responsive bidders, the said may be decided through free toss which shall be considered as final.
9. The bidder shall have the relevant codes as per Pakistan Engineering Council against each mentioned work.
10. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPR) under the Khyber Pakhtunkhwa Finance Act 2013.

11. The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e. Tender Form, BOQ duly signed and stamp, SBDs, fresh LCB Registration, CNIC copy, active NTN/Income Tax Certificate, valid PEC License upto 2026, Active fresh KPPRA Registration.
12. The quoted rate must be clearly mentioned in words and in figures on tender form. Incomplete over writing dis-figuring will not be acceptable and any mismatching, materially inaccurate, incomplete or do not send information in hands form among the scanned copies submitted through EPADS will be dis qualification and considered as non-responsive as per KPPRA rules.
13. The firms/contractors who want to participate in tendering process must be registered themselves with the EPADS for gaining their unique username and password.
14. All material testing and all sorts of tests will be performed by contractor on the demand of procuring entity at the cost and risk of the contractor.
15. The Bid Security and Additional Security shall be submitted as per KPPRA Notification No. S.R.O(1-4)Vol:1-24/2011-22/6053-71 dated 10.05.2022.
16. As per KPPRA Notification No. S.R.O/Vol:1-40/2025-26/699-711 dated 29.10.2025, bidders are required to enter detail of bid security and additional security in EPADS and the same shall be submitted to the procuring entity well before closing time and date and the same will be retained by the procuring entity until the award of contract or bid validity whichever come first. Failure to do so action will be carried out as per the mentioned notification.
17. In case, the contractor in not successful than 2% call deposit ^ Additional Securities (if any) will be refunded after signing the agreement of the scheme between successful bidder and the department.
18. Work order will be issued on the availability of (100%) funds with TMA Serai Naurang.
