2. The bidders shall clearly and boldly mark the ITB No./Title and date/time of opening at the face of the sealed bid/envelope.
3. The interested and eligible bidders/contractors duly registered on EPAD are eligible to apply under Single stage – Two Envelope method of KPPRA Rules. Manual submissions of bids are not accepted as per Rules.
4. The duly completed sealed bids must be submitted through E-Pad System as per the schedule above.
5. The bid shall invariably be accompanied by Bid Security @ 2% of bid cost (Refundable) in the form of CDR drawn in the name of 'Director General Soil & Water Conservation Khyber Pakhtunkhwa', failing which the bid shall be outrightly rejected.
6. The bid must be accompanied by a refundable Bid Security of 2% of the bid cost in the form of an ORIGINAL CDR drawn in the name of "Director General Soil & Water Conservation". The Original 2% CDR and the affidavit shall be sealed in separate envelopes, placed in one large sealed envelope, and submitted to the address below before the closing date and time, failing which the bid shall be rejected.
7. Pre-bid meeting and Proposal opening will be held in the Office of the Director General Soil & Water Conservation, Khyber Pakhtunkhwa, in the presence of the bidders.
8. The Director General reserves the right to reject any or all bids per the rules in vogue.
