Terms & Conditions:


- Bidding documents can downloaded from the official EPAD website i.e (eprocure.gov.pk) after publishing NIT on KPPRA. The BSD will be filled neatly and clear and a scan copy of the same will be uploaded at the time of apply (Bid submission) through EPADS.
- The award of contract shall be on the basis of above/ below engineer estimate on MRS-2025 (1" Bi Annual) instead of item rate.
- Earnest money & additional securities shall be prepared in light of KPPRA Notification, No S.R.O. (14)/Vol.1-24/2021-22 dated 10" May, 2022.
- The bid Securities shall be in shape of call deposit receipt in favor of Procuring entity.
- Bids and Original Call Deposit received through fax or by hand will not be acceptable. Sealed bids send through registered mail/ courier service should reach up to specified date and time as mentioned above.
- Sealed bids sent through Registered Mail/Couriers Service should be reached on due date and time (mentioned above) in the presence of bidders or his representative by The Tender Committee.
- These documents are compulsory with tender form: i. Fresh Registration of LCB. ii. Fresh Registration of KP Revenue Authority BOQ duly signed and stamp. iv. The attested CNIC copy of MD/owner duly attested by 17 or above officer v. active NTN/Income Tax certificate.
- After issuing the work order, if the contractor/firm do not commence the work in one week, then the tender will be cancelled including forfeiting of security.

9. Issuance of work orders/ commencement of work on the above schemes shall be subject to availability of funds.
10. According to the Government Laws, all the taxes will be deducted.
11. In case of receiving equal offers, the award of contract shall be decided through a free toss which shall be final.
12. Any cutting/over-writing on the BOQ will be liable to rejection of the tender and will be declared non-responsive.
13. The procuring entity may reject all bids or proposals at any time to the acceptance of bids or proposals in light of KPPRA Rules-47.
14. The rules and regulation/instructions in future if issued by provincial Government of KPK will be applicable.
15. As per clause 37 (A) of KPPRA Rules. All bidders must be registered with Khyber Pakhtunkhwa Revenue Authority.
16. As per KPPRA advice insurance bond will not be accepted.
17. Open draw will be conducted after verification of CDR's from banks.
18. Any addition made in terms and conditions in the NIT advertised in the newspaper or published on KPPRA website will be implemented as per KPPRA Rules.
19. The work order will be issued, subject to availability of fund.

Note: The work order will be subject to the release of funds by the provincial government. In case of non-release of funds, the tenders will be considered cancelled. The contractor will not be authorized to file/claim or challenge in any departments/ courts.
