In accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules 2014, the Directorate of Works & Implementation, Sports and Youth Affairs Department, Government of Khyber Pakhtunkhwa, hereby invites Electronic Bids from eligible firms/bidders through the E-Pak Acquisition and Disposal System (EPADS) online bidding system for the following work(s) under the Single Stage – Two Envelope Procedure:

1. The Bidders should have Active Registration with Pakistan Engineering Council (PEC) and experience/expertises in relevant field of Specialized Nature of Works only.
2. Technical evaluation will be carried out as per the criteria defined in the bid solicitation documents.
3. All bids must be accompanied by Bid Security @ 2% of the engineer's estimate along with additional security, if applicable as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22, in the name of Deputy Director (Works), Directorate of Works & Implementation Peshawar Khyber Pakhtunkhwa.
4. Bids must be submitted, including the Technical Bid, Financial Bid, CDR, and additional security / rate analysis (if applicable), through the EPADS (E-Pak Acquisition and Disposal System) portal (<https://kp.eprocure.gov.pk/>) on or before Due Date & Time.
5. The CDR in hard copy, must reach the office of the undersigned on or before the due date and time.
6. The procurement shall be processed under the Single stage – Two Envelope procedure under Rule 12(2)(b) of the KPPRA Rules, 2014.

7. The bidders are required to quote their rates (electronically) "ABOVE/BELOW/AT PAR" for both priced BOQ/Engineer Estimate based on MRS-2025 and NSI items as well. Only two digits after the decimal point shall be considered for evaluation purpose.
8. All other items not mentioned in the BOQ but exist in the MRS-2025 shall be paid to the contractor's rate approved by the competent authority with approved area cost factor.
9. The bidding process will be carried out as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22.
10. The notification S.R.O No. (15)/Vol: 1-25/2022-23 amended vide notification No S.R.O (18)/Vol:1-28/2023-24 will also be applicable.
11. Successful bidder should sign the contract agreement with the department within the stipulated time.
12. All the information and documents provided by the bidder must be based on facts beyond any doubt. During analysis / Scrutiny or evaluation of the proposals any misrepresentation, false statement or fake document would make a ground for rejection of the bid and will also be liable for debarment / blacklisting. Any fake document or misrepresentation detected during the currency of the contract, will render the firm to be black listed and would be reported to the PEC for cancellation of their registration/license.
13. The bidder shall provide No litigation certificate with the procuring entity.
14. Bids will be valid for a period of ninety (90) days.
15. In case evaluated bids of two or more than two bidders are the same then the successful bid will be declared through open draw.
16. All prevailing rules of KPPRA issued from time to time shall be observed during the procurement process.
17. Bid securities of 1st, 2nd and 3rd most competitive bidders will be retained by the procuring entity till the approval of bids.
18. In the event that any of the deadlines given for bid submission falls on a public holiday, the activity will be carried out on the following working day.
19. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
20. The bidder must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) and must be on active tax payer list (ATL).
21. The bidders must have completed at least two (2) projects of a similar nature, such as Futsal Grounds, Athletic Tracks, or Hockey Turfs, during the last three years. Each project must have a value of not less than engineer's estimated cost mentioned in the NIT, otherwise, the bid will not be considered acceptable and it will be considered dis-qualified.
22. Joint Venture (JV), will not be accepted.
23. The bidder must demonstrate ownership / lease agreement of key construction equipment (excavator, roller, compactor, concrete mixer, etc) relevant to playground works must be signed and stamped.
24. Documents of staff must be duly signed and stamped, and a valid (fresh) biometric record must be attached otherwise the firm will be considered disqualified.
