

INVITATION FOR BIDS THROUGH E-PADS
(INTERNATIONAL COMPETITIVE BIDDING)

The Office of the Registrar, Peshawar High Court (PHC), Peshawar, Khyber Pakhtunkhwa has received an allocation from the Public Fund in Pak rupees & invites E-Bids/Proposals under KPPRA Rules 2014 as amended from time to time through rule Single Stage Two Envelopes 6(2)(b) bidding method/Procedure through Electronic Government Procurement (e-GP), E-Pakistan Acquisition & Disposal System (E-PADS) from well-reputed and financially sound International & national manufacturers/Importers/Authorized Agents/ Companies registered with the relevant Government registration authorities and Tax Departments/Authorities i.e., SECP, FBR Income tax, Sales Tax as well as Khyber Pakhtunkhwa Revenue Authority (where applicable) etc. for the procurement & supply of the following official Government Armoured vehicles. Terms & Conditions:

1. The bid solicitations documents containing all information on terms & conditions, bidding method, evaluation procedure, schedule of requirements & technical specifications, etc. can be downloaded online at Government official web portals i.e., <http://www.kppra.gov.pk>, <https://kp.eprocure.gov.pk>. & The Peshawar High Court <https://peshawarhighcourt.gov.pk/app/site/> before the closing date and time.
2. Bidders are advised to ensure uploading the Bids on E-PADS Portal, well before the submission deadline, and not wait for the last date and time to upload the bid. Bid submission on E-PADS Portal shall entirely be the responsibility of the bidder. Office of the Registrar, Peshawar High Court, Peshawar, Government of Khyber shall not be held responsible for any issues thereof. For any assistance regarding **E-PADS Portal**, system support email and phone numbers are provided on the **Federal PPRA's website**.
3. All prospective bidders shall be required to quote financial bid both on Delivered Duty Paid (DDP) Basis & Cost Insurance Freight (CIF) basis. DDP based quoted bid shall be in Pakistani Rupees & CIF based quoted bid shall be in US Dollar. The bidders are requested to offer their best & final bids/prices as no financial negotiations are expected.
4. Conditional or alternate/optional bids shall be rejected.
5. E-Bids or Proposals tender submission in closing date is **15.05.2026 till 11:00 AM (Pakistan)** & will be opened on the same day, date at **11:30 AM** in the office of the **Registrar, Peshawar High Court, Peshawar**, through e-PADS in the presence of bidders or their representatives who wish to attend.
6. Taxes, duties & levies etc. will be deducted as per the prevailing Government rules.
7. **Pre-bid meeting** will be held on **01/05/2026, 11:00 AM** in the office of the Registrar Peshawar High Court, Peshawar. Potential bidders are encouraged to attend the pre-bid meeting on the mentioned venue, date & time.
8. E-bids or Proposals with complete bidding documents on official business letterhead including Technical & Financial bids/documents (inclusive of all taxes) duly signed,

stamped and in complete conformity with the bid solicitation documents shall be separately submitted by the prospective bidders online on the Government E-Procurement system (EPADS) website i.e., <https://kp.eprocure.gov.pk>.

9. Original Bid Security in shape of Call Deposit Receipt (CDR) scan copy shall be uploaded online on the EPAD along with financial bid while original hard copy shall be submitted in a sealed envelope at or before the tender closing date & time in the office of the Registrar, Peshawar High Court, Peshawar. In case of non-compliance, bid will be considered as non-responsive.
10. The approved rate shall be valid for **Eight (08) months** from the date of award of contract to the successful bidder.
11. The Procuring Entity as deem appropriate under the rules reserves the right to increase or decrease the quantity
12. In case of a public holiday due to any reason, the date of opening the tender will be considered the next working day.
13. The Procuring Agency reserves the right to reject any or all E-Bids or proposals at any time before the acceptance of E-Bids or proposals under Rules 47 of KPPRA 2014.
