The hard copy of the bid must be sent to the office of the Executive Engineer, PHE Division, Kurram, through registered courier service before the bid submission due Date/time.
3. The Financial bids must be accompanied by a Bid Security equal to Rs. @ 2% of total Estimated Cost of the project in the shape of CDR along with the stamp duty.
4. Technical bids will be opened at **01:30 PM** on **06.05.2026** in the office of the undersigned, in the presence of the bidders or their authorized representatives.
5. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.

The bidder quoting their bids more than 10% below up to 20% below on Engineers Estimates shall submit along with their bids 08% additional security of Engineer's estimated cost in addition to 2% security Other conditions notified vide KPPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058- 71 dated Peshawar, 10/05/2022.
7. Non-refundable bidding entry fee @ 0.03% of the estimated cost shall be submitted with bids in the shape of call deposit (in original) in the name of the Executive Engineer PHE Division Kurram.
