3. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements, which will be communicated to the bidder after technical evaluation through the provided email address.
4. ORIGINAL two (2%) bid security of the total bid price in the shape of CDR in the name of "TMO TMA Lower Mohmand" shall be sealed in envelope and marked as such and shall reach on below given address before the closing date and time.
5. All applicable taxes including Sales tax, Income tax, KPRA taxes, stamp duties etc. as per Government Rules enforced shall be applicable.
6. All the rates shall be quoted on (FOR) basis with free supply / delivery to the TMA office.
