INVITATION FOR BIDS THROUGH EPADS

(FRAMEWORK AGREEMENT)

The **Director General, Excise Taxation and Narcotics Control, Khyber Pakhtunkhwa**, invites sealed bids under National Competitive Bidding (NCB) for the "**Procurement of Passive Ultra High Frequency (UHF) RFID Tags and Handheld RFID Readers**" on a **Framework Contract Basis** (as per KPPRA Rule 31A). Bidding shall be conducted in light of **Rule 6 (2) (b) "Single Stage – Two Envelopes"** procedure of KPPRA Rules 2014, from well-reputed Manufacturers or their Authorized Dealers/Distributors registered with Income and Sales Tax authorities and appearing on the Active Taxpayer List (ATL) of FBR.

1. **Framework Contract Details:** In accordance with **KPPRA Rule 31A**, the contract shall initially be executed for a period of **one (1) year**, extendable up to a maximum of three (3) years subject to approval and value-for-money assessment. Procurement will be made on a "need basis" at fixed unit rates during the contract period.
2. **Bid Solicitation Documents:** Detailed descriptions, technical specifications, and evaluation criteria may be downloaded from the EPADS portal (<https://kp.eprocure.gov.pk>) or from www.kppra.gov.pk and www.kpexcise.gov.pk.
3. **EPADS Clarifications:** Any queries or requests for clarification regarding the bidding documents must be submitted **strictly and only through the EPADS system**. The deadline for submitting clarifications is **April 30, 2026, by 11:00 AM**. No clarifications shall be entertained or accepted after this deadline.
4. **Registration:** Bidders must be registered with EPADS to obtain a unique username and password for participation.
5. **Bid Submission:** Bidders must upload scanned copies of Technical and Financial proposals separately on the EPADS system (<https://kp.eprocure.gov.pk>) on or before **May 06, 2026 (11:00 AM)**.
 - **Strict Compliance:** Only those bids that are successfully uploaded and received through the EPADS system before the stipulated deadline will be considered for further processing.
 - **No Physical Bids:** Physical submission of bids (by hand, post, or courier) is **strictly prohibited** and shall not be entertained under any circumstances.
 - **Late Bids:** Any bid not appearing on the EPADS portal by the deadline will be automatically rejected.
6. **Bid Opening:** Technical bids shall be opened on **May 06, 2026, at 11:30 AM** in the office of the undersigned. Financial bids of technically qualified bidders will be opened subsequently.
7. **Bid Security:** A Bid Security of **Rs. 80,000/-** in the form of a Call Deposit Receipt (CDR) or Demand Draft (DD) in the name of "**Director General Excise, Taxation and Narcotics Control, Khyber Pakhtunkhwa**" must be uploaded to EPADS. The original instrument must be physically submitted to this office before the submission deadline.
8. **Pre-Bid Meeting:** A physical pre-bid meeting will be held on **April 30, 2026 (02:00 PM)** at the Directorate General Excise, Hayatabad, Peshawar.
9. **Rejection of Bids:** The Competent Authority reserves the right to reject any or all bids as per provisions contained in **Rule 47 of KPPRA Rules 2014**.
