NOTICE INVITING TENDER THROUGH E-BIDDING (EPADS)

Single Stage Two Envelop Bidding System

Office of the District & Sessions Judge Abbottabad, invites sealed bids under national competitive bidding for the procurement/supply/service and installation of the following equipment's in light of Rule 6(2)(b) "Single Stage Two Envelopes" procedure of KPPRA Rules 2014 and EPADS, from contractor/manufacturers/service providers or their authorized dealers/suppliers/representative registered with income tax/sales tax and reflected on active tax payer list (ATL) of FBR. The rates should be quoted in FOR.

1. The bids shall be valid till 30th June 2026.
2. The interested firm must be registered with KPPRA EPADS.
3. The EPADS registered firms will submit their bids online through EPADS portal as well as submit original, bid hard copies to the office of District & Sessions Judge, Abbottabad.
4. The project must be on turn key basis, all the installation and configuration must be done by the bidder/ firm.
5. The advertisement and Bid Solicitation Documents can be downloaded from the official website of District Courts Abbottabad at (<https://abbottabaddc.peshawarhighcourt.gov.pk>) and (www.portalkp.eprocure.gov.pk).

6. Complete tender documents must reach the office of undersigned by 11:00 am on 11th May, 2026. Tenders received after due date and time will not be considered.
7. Bids will be opened at 12:00 Noon on the same day in the Conference Room of District Courts, Abbottabad, in the presence of members of the procurement Committee and the bidders or their authorized representatives who wish to attend.
8. The Bidders are required to submit earnest money/bid security @ 2% of the quoted value in the form of Call Deposit Receipt in the name of District & Sessions Judge Abbottabad.
9. Technical bid must be accompanied with an affidavit that "original CDR be sealed and placed in financial bid" failing which the technical bid will be considered non-responsive.
10. The bidders are required to submit an affidavit to the effect that the prospective bidder is not blacklisted by any Provincial/Federal department or autonomous organization.
11. All admissible taxes (Income tax, GST etc.) will be deducted.
12. Each envelope must contain separate Technical and Financial bids, clearly marked in bold and legible letters. Firms must provide complete contact information, including postal address, valid email address, and phone number, on each respective envelope.
13. Competent authority reserves the rights to reject any or all the bids as per provision contained in Rule-47 of KPPRA 2014.
14. The Competent Authority may increase/decrease the number of items as per sanction/allocated budget.
15. Interested bidders may visit/contact the office before submission of bids for any query/confusion/information on the given official Number i.e., 0992-921051.
16. Delivery/installation of items may be supplied/install within 15 days of the issuance of supply order positively, failing which the supplier shall be dealt with according to law.
17. The Competent Authority may also postpone or cancel the procurement without assigning any reason.
18. The procured items may be delivered, supplied, or installed at District Courts Abbottabad & Tehsil Courts Havelian.
